A RESOLUTION APPROVING STUDENTS ELIGIBLE FOR SUBSIDY (REIMBURSEMENT IN LIEU OF TRANSPORTATION)

FOR THE 2022-2023 SCHOOL YEAR

WHEREAS, the Cincinnati City School District has identified an additional Seventy-three (73) pupils, bringing the total to seven hundred and forty-six (746), to be residents of this school district and eligible for transportation services; and

WHEREAS, after a careful evaluation of all available options, it has been determined that it is impractical to provide transportation for these students to their selected schools; and

WHEREAS, the following factors as identified in Ohio Revised Code 3327.02 have been considered on a student-by-student basis:

- 1. The time and distance required to provide the transportation
- 2. The number of pupils to be transported
- 3. The cost of providing transportation in terms of equipment, maintenance, personnel, and administration
- 4. Whether similar or equivalent service is provided to other pupils eligible for transportation
- 5. Whether and to what extent the additional service unavoidably disrupts current transportation schedules
- 6. Whether other reimbursable types of transportation are available; and

WHEREAS, the option of offering payment in lieu of transportation is provided in Ohio Revised Code:

NOW THEREFORE BE IT RESOLVED, that the Cincinnati Board of Education, in accordance with ORC 3327.2 and Board Policy 8600.02, declares an additional Seventy-three (73) pupils, bringing the total to seven hundred and forty-six (746) pupils impractical for transportation; and

BE IT FINALLY RESOLVED, that the Cincinnati Board of Education approves the declaration of impractical to transport for the identified students for the 2022-2023 school year.

RESOLUTION AUTHORIZING THE FILING OF AN ORIGINAL BOARD OF REVISION COMPLAINT – AS AUTHORIZED BY OHIO REVISED CODE § 5715.19 – WITH THE HAMILTON COUNTY BOARD OF REVISION, ASKING THAT THE TRUE VALUE OF THE PROPERTY LOCATED AT 2147 PATTERSON STREET AND 2150 WINCHELL AVENUE BE INCREASED TO THE AUGUST 2021 SALE PRICE OF \$3,249,213

WHEREAS, the subject property located at 2147 Patterson Street, Cincinnati, OH 45214 and 2150 Winchell Avenue, Cincinnati, OH 45214 (Parcel Nos. 184-0006-0137-00, 184-0006-0123-00) appears to have been sold in an arm's-length entity sale on August 31, 2021 for \$3,249,213; and

WHEREAS, the following is true of the sale: 1) The sale occurred before the tax lien date of January 1, 2022; and 2) the sale price exceeds the current value by both 10% and \$500,000; and

WHEREAS, the record owner of the subject property is 2150 Winchell Investments LLC; and

WHEREAS, this Resolution would authorize the filing of an original complaint asking that the true value of the subject property be increased to the sale price for Tax Year 2022, with the basis of the complaint being R.C. 5715.19(A)(1)(d) (the determination of the total valuation or assessment of any parcel that appears on the tax list); and

WHEREAS, this resolution contains all of the information required by R.C. 5715.19(A)(7)(a)-(d), including the following: 1) Identification of the parcel(s) that are the subject of the complaint by street address and by parcel number; 2) the name of at least one record owner; 3) the basis of the complaint under divisions 5715.19 (A)(1)(a)-(f) relative to each parcel identified; and 4) the Tax Year for which the complaint will be filed; and

WHEREAS, the owner(s) of the subject property were properly notified of this resolution at least seven days in advance of adopting the resolution, via certified mail to the last known tax-mailing address of at least one of the record owners and to the address of the parcels identified in this Resolution, pursuant to 5715.19(A)(7); the Notice included the following information: 1) The intent of the Board of Education in adopting the resolution; 2) the proposed date of adoption; and 3) the basis for the complaint under (A)(1)(a)-(f).

NOW THEREFORE BE IT RESOLVED, that the Board of Education is authorizing – pursuant to and in accordance with R.C. 5715.19 – the filing of an original complaint with the Hamilton County Board of Revision, asking for an increase in the value of the subject property to the sale price.
