# Presentation: Tobacco 21

*Jeff Gaylor, American Heart Association, Vice President Megan Folkerth, Interact for Health, Program Officer* 

Ms. Folkerth and Mr. Gaylor updated the Committee on their initiative to raise the age of selling tobacco to 21.

The Presentation included information about:

- Use of tobacco by youth in any form is unsafe;
- The seriousness of ending the tobacco epidemic among youth in the United States;
- Statics of tobacco use among youth;
- Factors associated with youth tobacco use;
- States who have initiated Tobacco 21 laws; and
- Cincinnati's tobacco Ordinance.

The American Heart Association is asking the District for support of the below resolution to raise the age of sale of all tobacco products to 21. The document is also being submitted to the legislature to show CPS' support of the initiative.

# DRAFT RESOLUTION CINCINNATI PUBLIC SCHOOL BOARD OF EDUCATION

A **RESOLUTION** of the Cincinnati Public School Board of Education of the City of Cincinnati expressing support for the Cincinnati Tobacco 21 initiative.

**WHEREAS**, young people are particularly susceptible to the addictive properties of tobacco products, and are particularly likely to become lifelong users; and

**WHEREAS**, national data show that 95 percent of adult smokers begin smoking before they turn 21; and

**WHEREAS**, the ages of 18 to 21 are a critical period when many smokers move from experimental smoking to regular, daily use, and tobacco industry documents show that those who start smoking by the age of 18 are almost twice as likely to become lifetime smokers as those who start after they turn 21; and

**WHEREAS**, an estimated 5.6 million Americans under the age of eighteen are projected to die prematurely from a tobacco-related illness if prevalence rates do not change; and

**WHEREAS**, in 2015, the Institute of Medicine concluded that raising the minimum legal age for tobacco nationwide will reduce tobacco initiation, particularly among adolescents aged 15 to 21, improve health across the lifespan, and save lives; and

**WHEREAS**, smoking amongst young people in the City of Cincinnati is a challenge that will lead to long-term health effects, but also create a new generation of children that will experience the negative effects of tobacco use; and

**WHEREAS**, tobacco use is the most preventable cause of premature death in the United States, causing half a million deaths annually, and it has been responsible for 20.8 million premature deaths in over the past 50 years since the first Surgeon General's report on smoking in 1964; and

**WHEREAS**, a local licensing system for tobacco retailers is necessary and appropriate to protect the public health, safety, and welfare of our students; and

**WHEREAS**, the Cincinnati Public School Board of Education recently revised their tobacco use policy (7434) and resoundingly supported the inclusion of the recommendations of the Cincinnati Health Department and is very concerned with the health and well-being of its students; now, therefore,

**BE IT RESOLVED** by the Cincinnati Public School Board of Education of the City of Cincinnati, State of Ohio, that:

**Section 1.** That the Board supports prohibiting the sale of tobacco products, inclusive of e-cigarettes and paraphernalia, to those under the age of 21 within the City of Cincinnati.

**Section 2.** That the Board respectfully encourages Cincinnati City Council to pass an ordinance amending the Cincinnati Municipal Code to prohibit the sale of tobacco products and paraphernalia to those under the age of 21, to create a retail tobacco license, and to empower the Cincinnati Health Department to administer the license program and to enforce the program through civil processes.

**Section 3.** That the Board encourages other local communities across Ohio and the State of Ohio to prohibit the sale of tobacco products and paraphernalia to those under the age of 21 as a part of efforts to further reduce tobacco use and the negative health impacts associated with it.

ACTION: The Committee reviewed the resolution and recommended to amend Section 1 of the document to include: within the boundaries of the Cincinnati Public School District language.

If adopted, this resolution will be reviewed in Committee at Cincinnati City Council and forwarded to City Council for discussion in early December 2018.

- ACTION: General Counsel will review *Policy* 7434 *Use of Tobacco* to determine if revisions are pertinent to the Tobacco 21 initiative upon legislative approve.
- ACTION: Committee Chair Bates informed the American Heart Association to reach out to the municipalities that are a part of CPS to include them in the initiative. Mr. Hoying will provide Ms. Folkerth with a list of CPS students within the jurisdiction of the municipalities.
- ACTION: The Policy Committee will recommend the resolution to the Board for approval at the November 28, 2018 Business meeting

### The Policy Committee reviewed the following policies and recommended the following Actions:

• Policy 2260 – Nondiscrimination and Access to Equal Educational Opportunity and Policy 2260.01 – Section 504/ADA Prohibition Against Discrimination Based on Disability were recommended for approval at the October 22, 2018 Regular Business Meeting in the form of a resolution.

The Policy Committee is resubmitting both policies for approval in a separate resolution for recommendation of approval at the November 28, 2018 Regular Business meeting.

• **Policy 5600** – **Student Discipline** The Committee reviewed the policy and recommended to include language on Restorative Practices, Trauma and PBS work and remove "zero-tolerance" language.

The Committee recommended additional revisions to the document and will recommend approval at the November 28, 2018 Regular Business meeting.

# **Preschool Enrollment Data Report**

Vera Brooks, Interim Director of Early Childhood, continued her discussion and provided additional information on the possibility of moving back the cutoff date for entering preschool and kindergarten from a September 30 birthday to an August 1 birthday.

She discussed preschool enrollment data up to grade three that included 2013-2014 KRAL composite scores information, and birth month impacted outcomes.

Ms. Brooks informed the Committee that there was no significance of the birth months impacting the ELA scores. The greatest indicator that improved the scores was not the birth month, but a child's preschool experience. She reported students having more preschool experience did well.

The Committee concurred that there was not compelling evidence to change the entrance date into preschool or kindergarten.

A copy of the report is attached at the end of this Policy Committee meeting report.

ACTION: The Committee advised Ms. Brooks to simplify the report, inform the schools about the findings, and also advise schools that the Policy Committee has addressed the concern.

# <u>Policies and Procedures Regarding Prevailing Wage/Women and Minority/Local Minority</u> <u>Contractor Expectations</u>

The Committee reviewed these policies due to the new FC stadium and the laws the District must adhere to that the City does not.

Mr. Hoying reported that *Policy* 6450 – *Equal and Fair Opportunity in Contract Employment* and the Board's June 2004 *Resolution on Equal and Fair Opportunity in Contract Employment and Business Opportunities* are the CPS policies.

- ACTION: Mr. Hoying will review the below policies as they are both duplicated in the policy files to ensure which are the most current, need combining and are aligned.
  - Policy 6320 Purchasing of Goods and Services
  - Policy 6320.02 Determination of Responsible Bidders

The Committee expressed concerned about the District not having prevailing wage based on the law not permitting use of State prevailing wages. Mr. Hoying informed the group that Ohio Revised Code 4115.04 (c) states language about public authorities not being able apply prevailing wage.

The Committee is asking what other ways can the District use prevailing wage.

ACTION: The Policy Committee will look at prevailing wage langue from other District's around the State to fairly address the issue to ensure no exclusion of minority business.

The Committee will also use existing policies to address contracts, as contractors will need to live within CPS policies and state law.

# **Discussion of Internal Communication**

The Whistleblower policy, discussion of policy/procedure regarding surveys, and the staff communication shall be handled under the umbrella of Internal Communication.

Ms. Bates reported that there is concern that the community is not aware of what's going in the District or the schools. The community is approaching teachers about what's going in the District, and the teachers are sometimes not informed about what's going on in the District. A better way is needed for internal communications with staff.

ACTION: Ms. Bates reported that a bigger conversation is needed. The Committee advised the Administration to look at policies on communicating externally and internally and provide a draft of an internal communications policy.

Ms. Bates advised Mr. Hoying to review Baltimore's policies on internal communications and best practices and provide the information to the Committee in writing.

ACTION: Mr. Moroski advised to put more investment into the District's website to make it more user friendly

### **Community and Family Engagement Policy**

Committee member Bolton advised that a community and family engagement policy needs to be created and Lauren Worley is working on the document.

### **Ohio School Boards Association (OSBA) Essential Policies for 2019**

Committee member Bolton attended OSBA's Capital Conference from November 11-13, 2018 and provided Policy Committee members and the Administration with a copy of OSBA's Essential Policies for 2019.

#### **Board Assignment – Review Existing Survey Policies/Procedures**

This assignment is being handled under the broad topic of Internal Communication, as reported above.


#### FIGURE 1: **KRAL Composite Score Mean** 25.0 20.0 15.0 10.0 5.0 0.0 March 2008 April 2008 May 2008 June 2008 July 2008 January 2008 February 2008 August 2008 September 2008 October 2007 November 2007 December 2007 Birth Month Recode
