## 2020-21 SY Enrollment Information & Instructional Program

- **Kindergarten:** Added 1 class for 2020-21; 3 classes held to EIP Reduced Class Size Model (21 each)
- Lower Elementary: 6 mixed-age group classes held to EIP Reduced Class Size Model (21 each)
- **Upper Elementary:** 3 classes held to EIP Reduced Class Size Model (24 each)
- 2020-21 School Year:
  - 8/19 10/2/20: Phase I; full e-learning school-wide
  - <u>10/5/20 TBD</u>: Phase II; choice of full e-learning continuation or hybrid program incl. 2 days of in-person learning
  - All Specialized Instruction, Early Intervention Program and MTSS support ongoing; Title I Program re-starting
  - Physical Education, Art & Gifted Resource: will be offered for Semester 2
- **Specialized Instruction:** increased department size again to 6; Speech-Language service beginning for our students for first time since October 2019 & compensatory services being instituted
- Multi-Tiered System of Supports (MTSS): 56 students (23%) served in Tiers 2 & 3 by 1.5 interventionists
- Student enrollment: 246 students
  - Since the start of school 12 students withdrawn for homeschool, 13 withdrawn for face-to-face schooling options
  - 28 students (11%) have IEPs, 18 students (7%) have 504 Plans, 97 students (39%) are enrolled in EIP courses, 5 students (2%) are enrolled in Gifted courses
  - Demographics: 47% African American, 33% White, 10% Hispanic, 10% Multi-racial
