#### ADDENDUM TO RED HERRING AGREEMENT: RED HERRING MANAGED SERVICE EXTENSION

This Addendum ("Addendum") is entered into and made effective as of September 19, 2023, by and between the San Diego County Superintendent of Schools, hereinafter referred to as "County," and San Pasqual Union School District, hereinafter referred to as the "Agency." This Addendum is an extension of the existing agreement ("Agreement") between the parties, County Agreement number C20211302 dated April 1, 2021, regarding the use of the Red Herring phishing simulation services. County and Agency hereby agree to extend the current Agreement to include Red Herring as a Managed Service, with the following terms and conditions:

#### 1. Managed Service

- County will execute up to four (4) quarterly Red Herring campaigns per year, targeting staff members as outlined in the existing Agreement.
- County will furnish four (4) quarterly accompanying reports with a general overview of the campaigns per year. These reports will include relevant campaign data and insights.
- County will furnish one (1) annual report summarizing the campaigns and providing analytics on employee phishing awareness and knowledge checks conducted throughout the year.
- The Agency agrees to provide County with access to the directory service, which may include Active Directory, Azure AD, Google Workspace, or any other specified service, to synchronize user accounts with the Red Herring platform.
- The Agency agrees to allow County to perform the user account synchronization service on its behalf. This service will ensure that Red Herring has up-to-date user account information.
- The Agency will coordinate with County when reports generated by Red Herring indicate a need for staff members to change their passwords. This collaboration aims to enhance security and protect against potential threats.

#### 2. Contract Term

This Addendum shall be effective upon execution and shall remain in effect for the same term as the original Agreement.

# 3. Cost

This managed service is complimentary for San Diego County public school districts with fewer than 2,000 actively enrolled students. This complementary service will be provided until June 30, 2026.

Agency acknowledges that the complementary nature of this Manage Service is contingent upon the underlying Red Herring contract remaining in effect until June 30, 2026. If the Red Herring contract is terminated before the specified date, this complimentary service shall be terminated concurrently. In such a case, County may provide reasonable notice to the Agency regarding the termination of the Manage Service.

# **4.Terms & Conditions**

No term, unless specifically stated within this Addendum, is intended to revise, or replace those of the original agreement and the original terms shall remain in full force and effect as stated in the agreement.

# 5. Execution

This Addendum may be executed in counterparts, and electronic signatures shall have the same legal effect as original signatures. By signing below, the parties acknowledge and agree to the terms and conditions set forth herein.
