**RESOLUTION OF SUPPLEMENTARY AUTHORIZATION  
IN THE SINGLE SUBJECT AREA**

**WHEREAS**, the San Pasqual Union School District is required by Education Code to certify that teachers have met legal requirements to be authorized to teach in certain departmentalized subject areas, and

**WHEREAS**, the holder of a Multiple Subject or Standard Elementary Teaching Credential may teach, with his or her consent, any subject in departmentalized classes below grade 9 if the teacher has completed twelve to eighteen semester units, or six to nine upper division or graduate semester units of course work at an accredited institution, in the subject to be taught, and

**WHEREAS**, A person who holds a Single Subject or Standard Secondary Teaching Credential to be assigned to teach classes grades 5 through 8 in a middle school. The teacher must have a minimum of twelve semester units or six upper division or graduate semesters units of course work in the subject to be taught from an accredited institution, and

**THEREFORE BE IT RESOLVED**, that the Governing Board hereby determines, as required by Education Code Section 44256(b) and 44258.2 the following teachers have satisfied the above code requirement for the 23-24 school year and authorizes them to teach in those subjects: Employee Amanda Grano, Tim Harmon, Jenny Lynch, Jolene Mallory, Jake Mizel, Megan Mueller, Kim Read-Smith, Vince Timpe.
