#### TITLE IX SEX DISCRIMINATION/GENDER EQUITY COMPLAINT FORM

Title IX of the Education Amendments of 1972 ("Title IX") is a federal law that prohibits discrimination, harassment, exclusion, denial, limitation or separation based on sex or gender in all educational programs and activities, including athletic programs, and protects all participants in Lawndale Elementary School District's ("LESD") including students, parents, employees, and job applicants.

In addition to Title IX, California law and LESD policy prohibit discrimination based on sex, sexual orientation, gender, and gender identity or gender expression. (Ed. Code §§ 220-221.1.) It is the policy of the State of California that all persons should enjoy freedom from discrimination of any kind, and as such, California law expands upon sex and gender equity and Title IX laws within California's educational system. Therefore, no person shall be excluded from participation in, be denied the benefits of, or be subject to harassment or other discrimination in any academic, extracurricular, research, occupational training, or other program or activity on the basis of actual or perceived sex, sexual orientation, gender, or gender identity or expression.

If LESD knows or reasonably should know about any sex or gender-based discrimination, it must take action to eliminate such discrimination, prevent its recurrence, and address its effects. LESD must evaluate, investigate, and resolve complaints alleging sex or gender-based discrimination and conduct proactive investigations, as necessary, to examine potential systemic violations. Accordingly, LESD is responsible to resolve complaints of sex or gender-based discrimination promptly and equitably.

If you desire to file a complaint alleging sex or gender-based discrimination pursuant to Title IX and related California law, please complete the information referenced below and submit the completed form to LESD's Title IX Coordinator. The contact information for the LESD Title IX Coordinator is identified below.

This complaint form is intendent for use by the alleged victim of Title IX Sexual Harassment. Under Title IX and the Family Educational Rights and Privacy Act (FERPA), a parent or legal guardian may sign a complaint form and otherwise act on behalf of a minor in the formal complaint process.

Under federal law, only an alleged victim of sexual harassment who is currently participating or attempting to participate in the District's educational program or activities (such as an enrolled student, an employee, or an applicant for employment or admission) has the right to use the formal complaint process to initiate an investigation.
