 Meeting called to order at 5:01 p.m. to allow public comment on closed session agenda items. All members were present. Superintendent Burroughs and recording secretary, Pamela Hansen, were also present. No one addressed the Board. Adjournment at 5:05 p.m. for closed session.

Regular Session

- Regular meeting reconvened at 5:35 p.m.
- Public was welcomed. The flag salute was recited.
- Report from Closed Session: No action taken.
- Hearing of the Public: No one addressed the Board.
- Member Zdunich motioned to approve the current agenda and minutes from the 6/23/2021 regular meeting. Member Czerwonka seconded the motion. Motion passed 4/0.
- Superintendent Report:
 - o Thanked Member Spivey for his years of service to the Board
 - The district completed a successful summer school program for students with specific needs.
 - o Hosted various back to school teacher PD days
 - Mr. Burroughs welcomed new staff, including David Barker, Janet Miller, and Joyce Zeigen
- Foundation:
 - o Classroom modernization project nearly completed
 - o Gala (now called the Saints Soiree) on 10/2 at Rancho Guejito Vineyard *Diamonds and Denim*

 - o Sponsored teacher breakfast on 8/13
 - o Hosting "Boo Hoo, Woo Hoo" breakfast on 8/18
- Member Zdunich made motion to approve the procedure for filling a vacated Board of Education position. The board agreed to remove question 6 from the sample application and submit their choice of a question to the Superintendent for the interview questions by 8/27. Member Czerwonka seconded the motion. Motion passed 4/0.
- Superintendent Burroughs gave a presentation on the updated COVID-19 Safety Plan (Available on the SPU website).
