- **3**. **Course Access:** Students are enrolled in broad course of study that includes all required subject areas.

Pupil Outcomes:

- **4. Student Achievement:** Performance on standardized tests, score on Academic Performance Index, share of pupils that are college and career ready, and share of English Learners that become English proficient, English Learner reclassification rate.
- 5. Other Student Outcomes:

Pupil achievement as measured by multiple indicators of performance in required areas of study.

- **6. Parent Involvement:** Efforts to seek parent input in decision-making, promotion of parent participation in programs for unduplicated pupils and special needs subgroups.
