AGREEMENT: Tentative agreement between District and SPETA. Article 1 Agreement, Article 3 Definitions, Article 7 Negotiation Procedures, Article 12 Reassignment Procedures, Article 14 Complaint Procedures, Article 20 Health and Welfare Benefits, Article 21 Salary. The agreement includes a proposal to increase the salary schedule by 3% retroactive to July 1, 2018 for the 2018-2019 school year and increase the salary schedule by 1% effective July, 1 2019 for the 2019-2020 school year. In addition, the District will increase medical benefit contributions \$500 (from \$8,000 to \$8500) effective January 1, 2020.

Adjustments to salary apply to all certificated and classified staff except for the Superintendent. Adjustments to health benefits apply to all eligible staff.
