### **Regular Session**

- Public Hearing: No one requested to address the Board.
- Report from Closed Session: The Board advised the Superintendent to take appropriate action.
- Member Zdunich made a motion to approve the agenda and minutes from the 2/12/19 meeting. Member Czerwonka seconded the motion. Motion passed 4/0.
- Kymbee McKay, Kindergarten Teacher, had students present their Passion Projects.
- Nicole Zdunich, 5<sup>th</sup> grade Teacher, had students present a proposal for a project to help keep our campus clean that they hope to grow beyond SPU one day. (Available on the SPU website)
