Required Report Number One for the Low-Performing Students Block Grant

Improvement and Accountability Division

The Low-Performing Students Block Grant (LPSBG), established in <u>California Education Code</u> (<u>EC</u>) <u>Title 2</u>, <u>Division 3</u>, <u>Part 24</u>, <u>Chapter 3.2</u>, <u>Section 41570</u>, requires eligible local educational agencies (LEAs) receiving LPSBG funds to report to the State Superintendent of Public Instruction on the adopted plan to use the grant funds to increase the academic performance of the identified pupils. <u>EC Section 41570</u> also requires the California Department of Education (CDE) to compile and report this information to the appropriate policy and fiscal committees of the Legislature.

LEAs must report the required information using this web-based reporting tool on or before **March 1, 2019**. In order to submit this report, all questions must be answered.

The CDE will compile and submit the information received through this web-based reporting tool to the State Superintendent of Public Instruction and the appropriate policy and fiscal committees of the Legislature on behalf of all LPSBG-eligible LEAs.

The final apportionment of LPSBG funds to the LEA is contingent upon completing and submitting this report. **LEAs that do not submit this report will be required to return to the CDE all LPSBG funds that it may have received.**

Summarize how the funds will be used to increase or improve evidence-based services for pupils identified. (1036 of 1,050 maximum characters)

We anticipate the funds will be used in three (3) ways to increase student learning and well-being while more effectively engaging both students and parents. First, we intend to allocate approximately \$15,000 toward data visualization dashboard software. At present, we lack to the ability to effectively identify struggling students and to disaggregate existing student data at the school, classroom, support group, and student levels. Second, we plan to expend approximately \$20,000 to develop an effective School Improvement Committee. The committee will focus on school improvements through the lens of the Multi-Tiered Systems of Support (MTSS) model. Funds will pay for professional development and additional hours worked in support of program improvement. Finally, approximately \$15,000 will target increased student and parent engagement through improved communication tools. Specifically, we intend to update and integrate our school website with a new school app, instant mass messaging, and

How will the effectiveness of the evidence-based services be measured? (982 of 1,050 maximum characters)

Not only will a data visualization platform enable us to more effectively identify needed supports at the school, classroom, support group, and individual levels, the true measure of effectiveness will be increased student learning. As students are paired with supports and the effectiveness of those supports are actively monitored, the data will drive instructional practice to ensure that all students are receiving the support they need, when they need it. Concurrently, the School Improvement Team will utilize this and other data to recommend and implement systemic change to improve student learning and well being. With the Implementation of MTSS, we also anticipate less disciplinary actions, including fewer students removed from the educational environment. Finally, through the use of an integrated system connecting our website, app, and mass messaging systems, families will be more engaged in the school environment and better prepared to support their child.

How are services aligned with and described in the LEA's local control and accountability plan? (963 of 1,050 maximum characters)

The services and actions proposed are directly aligned with the San Pasqual Union School District's Local Control Accountability Plan (LCAP). First, all three LCAP goals focus on improving student achievement. Each of these three endeavors is intended to facilitate increased student achievement. Second, LCAP Goal 2 states that academic achievement will be improved through the use of data to guide instruction and improve professional practice. The data visualization dashboard is designed to provide this information in a timely and purposeful manner. Third, LCAP Goal 3 seeks to improve both academic achievement and school climate through student, staff, parent, and connectedness. While the implementation of MTSS would promote student well-being at school, the addition of an integrated school app connected to other resources will more effectively engage off-campus stakeholders like parents and the community.
