February 16, 2021

1.0 Call to Order

Meeting called to order at 3:34 pm on 2/16/2021 by Ms. Hunter

2.0 Roll Call: Debra Lucas, Deidra Nadal, Tamyke Edwards, Annaliese Liberto; Susan Hunter, Alicia Lanz Garvey, Kendra Ackerman, Sheri Lamoreaux

3.0 Additions/Changes to Agenda: None

4.0 Reading and Approval of Minutes

Reviewed (edited) minutes from Jan 19, 2021 meeting. Updates to budget summary to correct acronyms.

Motion to approve (with amendments): Ms. Lucas, seconded: Ms. Edwards. Approved unanimously.

5.0 Report of Officers/Committees

DAC- District Advisory Committee; Ms. Hunter attended and summarized: Jodi Marchesso provided a report on social-emotional learning (SEL), which is expected to be an especially challenging area for students when in-person learning returns. Ms. Edwards added that Ms. Marchesso is working with site Instructional Coaches to work with teachers about finding a balance of SEL with state curriculum standards. The no-contact rules are expected to be especially tough on younger students. In addition, Ms. Hunter reported that the DAC provided reminders to SSC about timelines and collaboration with other campus groups (ELAC, etc).

Budget update- CSI funds: Ms. Lucas received an email from Dr. Blanco on Feb. 6 email: "Amended outside consultant contract from Dr. Blanco's office. Per PUSD Executive Leadership Team's request, the cost of the CS Impact Services will be switched from site funds to central funds. The funds are now disencumbered." Thus, while NCES SSC voted in January 2020 to approve funding for CS Impact, those funds are no longer needed for that purpose and are now available to allocate again by NCES.

6.0 Unfinished Business

Membership: Motion by Dr. Lanz Garvey to nominate parent member, Sheri Lamoreaux to SSC; seconded: Ms. Ackerman. Approved unanimously.

2020-21 SPSA Vote: due to compliance issues in 2019-2020 school year, another vote for approval of the SPSA is required by the current, in-compliance SSC, followed by resubmission to the PUSD School Board.

Motion to approve: Ms. Edwards, seconded: Ms. Ackerman. Approved unanimously.

7.0 New Business

Update on i-Ready Diagnostic Math & Reading results: Ms. Lucas and Ms. Edwards reported that not all students have completed diagnostic yet, still in progress. Concern expressed about implications for students who have not shown sufficient progress, and what that means in this unusual year; this will be discussed again when results are available next meeting.

Update on SSC budget presentation to teachers: Dr. Lanz Garvey reported she presented at the staff meeting to teachers about the available CSI money to be allocated for the year-in-progress, as well as specific ways they can submit their input.

Comprehensive Safety Plan: Ms. Lucas reports she is working with parents and school nurse to update plan. Note this plan is a separate document from any in-person learning plans. An updated version will be sent, and will require a vote on the 2021-22 Plan via Emergency SSC Meeting prior to March 1, 2021.
