2021-22 School Overview

Phoenix Academy is a part of Marin's Community School - a county day program that serves students in grades 7 through 12 from districts in Marin County. These two schools operate with Oracle Independent Student, and Loma Alta/Juvenile Hall. Our combined mission for our program is to empower each student to follow their passions and lead purposeful lives.

Our vision: We will prepare ALL students with the knowledge, skills, and habits needed for success in college, career, and life. By deeply engaging each student through personalized learning experiences, our students will master rigorous academic content and develop skills for the modern workplace. Our students will become conscientious global citizens as they solve realworld problems and strengthen their connections to other people and the environment. Through our collaborative, supportive, and inclusive environment, our diverse students will develop their social and emotional skills and find individual pathways to achieve their goals.

Our academic model blends standards-based, integrated, project-based learning with mastery-based grading. Students develop content knowledge, and important academic and social-emotional skills to ensure success in whatever path they choose upon graduation. We engage students by helping them build mastery, autonomy, and purpose in their flexible learning opportunities. The culture of high expectations is supported by the deliberate cultivation of relational restorative practices that allow us to support each individual in his or her academic and social-emotional needs. We work with students and families to develop individual pathways for each and every student to meet their goals.

In the 2019-2020 school year, we significantly augmented our Learning Through Interest program so that more students are able to participate in learning off-campus through job shadows, internships, and co-enrollment in our local community colleges. Due to the pandemic school closures, we have operated a hybrid model of instruction whereby most students come on campus

for in-person support for some of the week, with other classes and support taking place over zoom. We continue to work with Public Health Guidelines to operate our school safely, and to maximize learning.

Statewide Assessments

Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. 2020-21 Career Technical Education Programs

Alternative Education students in Marin's Community School and Phoenix programs have access to the Marin County Office of Education's School to Career Program, and we also are working to develop our own more robust system. Students have access to support from our College and Career Specialist who has helped students find employment as well as job shadows and internships, especially in our summer program. In addition, we partner with Marin County Probation and their Employment Development Counselor to place our students in paid internships and paid jobs.

Our school collaborated with leaders through Big Picture Learning to expand our "Learning Through Interest (LTI) Program." Our LTI program is designed to support students' identity development and build their social networks as they pursue their individual goals. All of our students are enrolled in a College and Career elective where they are exposed to a wide variety of interests and opportunities to pursue through our Virtual Job Shadow Program. As students have interests that they like to pursue, we find mentors in our networks to connect with students through informational interviews, weekly meetings, work experience and in person internships when available.

2021-22 School Safety Plan

Every fall, as a component of Back to School activities, staff from Marin's Community School/Phoenix Academy, and all of our Special Education campuses review and discuss the Comprehensive School Safety Plan and address any changes needed to implement the plan to enhance school safety.

Administrators from each site complete an annual update evaluation which includes noting any support needed to implement the plan, as well as specify modifications that may be needed. Some of the key elements of the plan include child abuse reporting procedures, disaster preparedness, policies leading to suspension or expulsion, procedures to notify teachers of dangerous pupils, sexual and gender based harassment, bullying prevention, dress code, safe ingress and egress, and rules on school discipline.

Evaluation and updates are compiled and reported to the Board of Education at their February meeting on an annual basis. In an effort to ensure the health and safety of our staff and students as the highest priority, the work and school environments, practices and standard operating procedures have been modified. A three-phase plan has been implemented in coordination with Public Health for a sequential, cautious and deliberate approach to the return to site-based classroom instruction as of Fall, 2020. This plan has a focus on student learning and success. This plan requires close and ongoing coordination with all educational partners to maintain a flexible plan that works for our students, families, educators and community - with Marin County Public Health as our guiding partner.

Leading up to the 2020-21 school year, several mandates, orders and measures were directed by the Governor's Office, California Department of Public Health and Marin Public Health. The MCOE is committed to following all state and local guidance and will update procedures as necessary to remain consistent with any future guidance received. Additional health and safety measures have been put into place during the COVID-19 pandemic. All activities and mitigation strategies are consistent with guidance from California Public Health, and Marin Health and Human Services guidance for schools.
