**Regular Board Meeting**

**1. Opening procedures**

- 1.1 Call to Order – Chairman Runge called the regular meeting to order at 8:02p.m.
- 1.2 Losekeled the Pledge of Allegiance.
- 1.3 Open Meeting Act – Chairman Runge noted the meeting would follow the open meeting act.
- 1.4 Verification of Publication and Notification – The agenda was posted in all school buildings and the meeting noticed was published in The Columbus Telegram.

Motion carried. It was moved by Loseke and seconded by Loseke to approve the resignation of Jill Stara as 5-12 instrumental music teacher and thank her for her service. On roll call vote, 6-0. Motion carried.
- 6.4 Approval of Contracts –It was moved by Loseke and seconded by Pabian to approve Logan Paben, Crystal Johannes, Carrie Jaixen and Jack Shadley as summer custodial help. On roll call vote, 6-0. Motion carried. - 6.5 Board Policy 415.01-the board tabled this to review further.
- 6.6 Negotiations-Executive Session. It was moved by Schreiber and seconded by Pabian to go into Executive Session for the purpose of discussing negotiation strategies to protect the public interest and the reputation of any individuals involved. It was moved by Loseke and seconded by Mueller to approve the Red Cross Shelter Agreements for the Lakeview and Platte Center buildings with the understanding that this use will not disrupt the educational function of the school buildings. On roll call vote, 6-0. Motion carried.
- 6.9 Facility Projects – Updates were given on the Summer Projects approved. The Lakeview Age/FFA Chapter is doing an upgrade to the greenhouse. It will be heated via Radiant Heat. Several grants, the greenhouse activity account and FFA account will pay for the project. The Shell Creek garage will be a project completed by a class. Bids were reviewed for a new mower. It was moved by Pabian and seconded by Schreiber to approve to purchase a new mower up to \$10,200 and the final mower to be decided by the Building & Grounds committee. On roll call vote, 6-0. Motion carried.
- 7.1 Board Committee Reports – Building & Grounds committee will meet on mower purchase. Policy committee will discuss Policy 415.01. Curriculum committee will meet to discuss K-3 Handwriting, the new Language Arts Standards and District Test Scores. Technology committee will meet to discuss Smart Search. Budget committee will meet in June.
- 7.2 Staff Recognition Luncheon-Will be held at 12:00 pm on Wednesday, May 20<sup>th</sup> in the Lakeview cafeteria.
- 7.3 Board Goals-No discussion.
- 8.0 Executive Session –It was moved by Schreiber, and seconded by Jaixen to go into executive session for the purpose of discussing personnel issues to protect the public interest and for the prevention of needless injury to the reputation of any individuals involved. On roll call vote, 6-0. Motion carried. The board entered executive session at 11:44 pm and exited at 12:21 am.
