## **INSTRUCTIONS TO BIDDERS**

## **GENERAL TERMS & CONDITIONS**

Complete units must meet all National and State of Idaho construction standards and specifications pertaining to school buses. Omission of any part of the National or State of Idaho specifications in the bid request shall not relieve the bidder of the responsibility of meeting these required standards and specifications.

It shall be the responsibility of the successful bidder to establish a definite date for delivery. Factory invoices shall be submitted with delivery of each truck, listing a breakdown of component parts. Required delivery date: As soon as possible, **no later than April 30, 2024.** 

Payment shall be made when complete box truck units are delivered F.O.B. Pocatello, Idaho and are deemed acceptable by Pocatello/Chubbuck School District No. 25.

The dealer shall submit complete specifications and descriptive data as published by the manufacturer. Also submitted shall be such photographs, charts, and drawings as may be necessary to enable the Board of Trustees to understand clearly and readily the mechanical features of the proposed body and complete units or chassis.

#### **BIDS:**

Sealed "BIDS" will be received on or before the time and date set forth under "INVITATION TO BID".

All bids shall be in a sealed envelope addressed: Business Office, 3115 Pole Line Road, Pocatello, Idaho, 83201. The following shall be written on the exterior of the envelope:

## "BID FOR FOOD SERVICE DELIVERY TRUCKS TO BE OPENED ON MARCH 5, 2024 AT 9:00 AM"

Bids not delivered at time of bid opening must be received in mail no later than 4:00 PM MST on March 4, 2024, the day before the bid opening.

Refer all questions to Heather Canfield, Food Service Coordinator, (208) 235-3256. Contact with other district staff, Board of Trustees, or Administration, will be by written permission only.

Before submitting a proposal, the bidder shall:

- 1. Carefully examine the specifications.
- 2. Include in the bid sums sufficient to cover all items required.

## **INTERPRETATIONS:**

Should a bidder find discrepancies in or omissions from the specifications, or be in doubt as to their meaning, he should at once notify the Owner, who will send written instructions or addenda to all bidders. The owner will not be responsible for oral interpretations. Questions received less than 48 hours before time for bid opening cannot be answered. All addenda issued during the time of bidding will be incorporated in the contract.

#### **BID GUARANTEE:**

Vendor shall be responsible for the delivery of materials of such quality and in specified quantity.

## **BIDDER'S RESPONSIBILITIES:**

- 1. Bid must be supplied on the attached Bid Form.
- 2. Submit complete specifications and descriptive data as published by the manufacturer. Include any photographs, charts, and drawings as may be necessary to enable the Board of Trustees to understand clearly and readily the mechanical features of the complete units.

## CONDITIONAL BIDS OR BIDS WITH STIPULATIONS WILL NOT BE ACCEPTED.

#### PAYMENT:

Prices must remain firm as quoted by supplier until quantity awarded is received. Application for payment dated on or before the 25th of the month, shall be paid by the 15th of the following month. Application for payment dated after the 25th of the month, shall be paid within 30 days.

#### **OBJECTIONS:**

Written objections to specifications or bid procedures must be received by the clerk, secretary, or other authorized official of the District at least one (1) business day before the date and time upon which bids are scheduled to be received, per Idaho Code Section 68-2806(c).
