The Livonia Public Schools Board of Education is accepting firm prime contractor bids for all labor, material, equipment and all other services to complete Interior Renovations at seven (7) Schools for the 2024 Summer Bond work.

Plans and specifications may be obtained electronically via [clarkccbids.com](http://clarkccbids.com) through Clark Construction Company on or after Tuesday, October 17 at 5:00pm. The bidding documents consist of plans and specifications as prepared by French Associates. The envelope bearing your proposal must identify your company and the proposal being bid and addressed to the attention of Phillip Francis, Assistant Superintendent, Livonia Public Schools 15125 Farmington Rd., Livonia, MI 48154. Bids must be delivered no later than **1:00pm, November 2, 2023**, to the Livonia Public Schools Central Office (address above), Attn: Phillip Francis, Assistant Superintendent. Bids will not be accepted at the Clark Construction office. Each proposal must be submitted on the forms furnished by the construction manager and must be completed in full. Each proposal shall be sealed in an opaque envelope and marked with the name of the bidder.

A Bid bond executed by a **U.S. Treasury listed surety company** acceptable to the owner, or a cashier's check in the amount of at least 5% of the sum of the proposal payable to Livonia Public Schools shall be submitted with each proposal in excess of \$28,000. All proposals shall be firm for a period of sixty (60) days. Oral, telephone, fax or electronic mail bids are invalid and will not receive consideration.

A pre-bid meeting will be held on Wednesday, October 25, 2023, at 3:00pm at Stevenson High School, 33500 W. Six Mile Rd. Livonia MI 48152. Please meet in the main entrance on the south side of the building. **This walk through is not mandatory, but highly recommended you will be able to visit all schools after meeting.**

All bids will be publicly opened and read aloud at the Livonia Administrative Offices (main board room) starting at **1:10pm on November 2, 2023**.

Successful bidders whose proposals are \$50,000 or more will be required to furnish a satisfactory Performance and Payment Bond in the amount of 100% of their bid. The cost of the Bond shall be included in each proposal.

All bids must be accompanied by a sworn and notarized statement disclosing familial relationship that exists between the owner or any employee of the bidder and any member of the Board or Superintendent of the Livonia Public School District. All bids must be accompanied by a signed and notarized statement to comply with the Iran Economic Sanctions Act of 2012 and Equal Opportunity Statement. Forms are included in the bid proposals.

The Board of Education reserves the right to accept or reject any or all bids, either in whole or in part; to award contract to other than the low bidder; to waive any irregularities and/or informalities; and in general, to make awards in any manner deemed to be in the best interests of the owner.
