## **Student Fees**

New Student Application Fee:	<b>Amount</b> \$85.00	per student paid electronically through FACTS immediately upon application
Enrollment/Reenrollment Fee <sup>c</sup> :	\$250.00	per student paid electronically through FACTS immediately upon enrollment.

<sup>&</sup>lt;sup>c</sup> Enrollment/Reenrollment must be completed by March 15, 2024. For returning families, after March 15, 2024, this fee will increase to \$350 if reenrollment is not complete. After April 30, 2024, the reenrollment fee will increase to \$450.

The following student fees will be billed through FACTS Incidental Billing and, while we prefer that student fees be paid in full on or before July 1, 2024, we will allow families to have these fees drafted in equal installments along with their FACTS tuition payment plan. Families must make their billing selection during online enrollment.

Capital Improvement Fee:	\$400.00	1 <sup>st</sup> student + \$50 per additional student
P.T.O. Dues	\$80.00	per family
Activities <sup>d</sup>	\$325.00	per student
Technology	\$140.00	per student
Senior Fee (Seniors Only)	\$200.00	per senior student

<sup>&</sup>lt;sup>d</sup> Activities fees cover Cardinal Newman student entrance fees to all Cardinal Newman home athletic events as well as admissions to all performing arts programs and student yearbooks.

Prior to April 30, 2024, families can withdraw their enrollment at any time with no cancellation penalty. Any application or re-enrollment fees paid are non-refundable for any reason regardless of the date of withdrawal. Between May 1, 2024, and July 1, 2024, any family wishing to void their tuition contract will owe a contract cancellation penalty of \$2,000 per student. This amount is due in full by June 1, 2024. After July 1, 2024, if a student is withdrawn for any reason, remaining tuition and consumable fees through the end of the academic year must be paid in full. If a student is asked to leave or withdraw from Cardinal Newman, the undersigned is responsible for the prorated annual tuition.

Monthly payments shown above assume that payments are made for 12 consecutive months beginning June, 2024, and ending May, 2025. All tuition must be paid in full by May 31, 2025. If payments do not begin in June, 2024, the monthly payments will be calculated as the total tuition divided by the number of months remaining until May. 2025.
