WHEREAS, the District has undertaken a reasonable review of the Capital Project and has determined that the project will benefit the District's students; and

WHEREAS, the District desires to enter into an agreement with the BOCES to share the cost of the Capital Project;

IT IS HEREBY RESOLVED that the Frankfort-Schuyler Central School District Board of Education hereby approves the Intermunicipal Agreement for the repairs, improvements and renovations to HFHO BOCES facilities, building and grounds, dated September 27, 2022, and authorizes the Board President to execute the agreement and authorizes the payment of money as set forth therein.
