Addendum to Employment Agreement Between Frankfort-Schuyler Central School District and Robert F. Reina: WHEREAS, the Board of Education of the Frankfort-Schuyler Central School District ("Board") and Robert F. Reina ("Superintendent") are parties to an employment agreement dated July 29, 2011, as amended by addendums dated December 5, 2011, June 11, 2013, May 5, 2015, December 16, 2016, March 13, 2018, and January 10, 2019 (the "Agreement");

WHEREAS, the Superintendent intended to retire on September 30, 2020, but at the request of the District, has agreed to continue his employment through August 31, 2020; and

WHEREAS, pursuant to the terms of the Superintendent's Agreement the Board has met to consider extending his Agreement and amending certain terms and conditions of his employment; and

WHEREAS, the parties wish to modify the terms of such Agreement as follows:

1. <u>Section 1</u> – Term is hereby amended to extend the term of the Superintendent's employment with the District through and including August 31, 2020.

2. <u>Section 4</u> – Salary is hereby amended to provide a salary of One Hundred Forty Eight Thousand and Twenty Five Dollars (\$148,025.00) for the 2020-2021 school year, pro-rated to reflect an anticipated resignation date of August 31, 2020.

All other provisions of the Agreement shall remain in full force and effect, in accordance with the terms of the Agreement and any subsequent addendums.
