## **School Attendance Areas**

Students shall attend school in the attendance area in which the parent or legal guardian (or in the case of an emancipated student) resides. Attendance centers shall be identified as: Springfield Elementary K-5, Tyndall Elementary PK-5, Bon Homme Hutterische Colony, Dawson Hutterische Colony, Bon Homme Middle School 6-8, and Bon Homme High School 9-12.

Assigned attendance areas within Bon Homme School District will be divided in the middle of sections when feasible. This will eliminate the need for two different buses traveling the same road as much as possible. The attendance area for each center shall include all real property assigned to Bon Homme School District as located (in full or part) of the following descriptions:

# **Bon Homme Middle School**

Middle School students shall attend Bon Homme Middle School. Students will be provided with bus transportation.

# **Bon Homme High School**

High School students shall attend Bon Homme High School. Those students living in excess of ten (10) miles from the high school will receive transportation. Students living closer than ten (10) miles will be provided transportation if they live on a route for elementary students or if they meet the bus at some point on an established route.

## Miscellaneous

Once the student resides within an attendance center, he/she must remain in that school until he/she moves to a different home site, graduates from the highest grade at that center, or the student is reassigned by the School Board, etc.

If a family chooses to enroll their children, according to school policy, in a school other than the one to which normal bus routes would transport their children, that family would be responsible for the transportation of their children. The shuttle system may be used to provide transportation in such a situation.

Any rural resident patron whose driveway approach intersects with an open section line (roadway) and the same section line is used to separate attendance area with Bon Homme School District may elect to attend either attendance center which borders that section line. Direct bus service will be provided to one site only.

This policy will be enforced from the date of adoption. Any and all students previously assigned by the School Board or initially placed by the parents (prior to the adoption of this policy) will be provided uninterrupted service at their current attendance center.
