COVID-19 Protocols and Mask Mandate	<p>On August 23, 2021 the Board adopted directives related to the COVID-19 pandemic. The Board reviewed and discussed these directives.</p> <p>Ms. Logan (Ms. Krehbiel) moved the Board discontinue the mask requirement currently in place effective at the conclusion of the business day on Thursday, March 10, 2022, and to recommend and welcome—but not require—masks in all district facilities and athletic or extracurricular events starting March 11, 2022.</p> <p>The motion passed 4-3, with Ms. Albert, Ms. Bond, and Ms. Stabler voting no.</p> <p>Ms. Bond (Ms. Stabler) moved the Board discontinue the mask requirement currently in place effective immediately.</p> <p>The motion failed 3-4, with Ms. Krehbiel, Mr. Reeser, Ms. Hedrick, and Ms. Logan voting no.</p>
<b>Adjournment</b>	<p>Mr. Reeser (Ms. Krehbiel) moved the meeting adjourn.</p> <p>The motion passed 7-0.</p> <p>At approximately 1:35 p.m., the meeting adjourned.</p>
