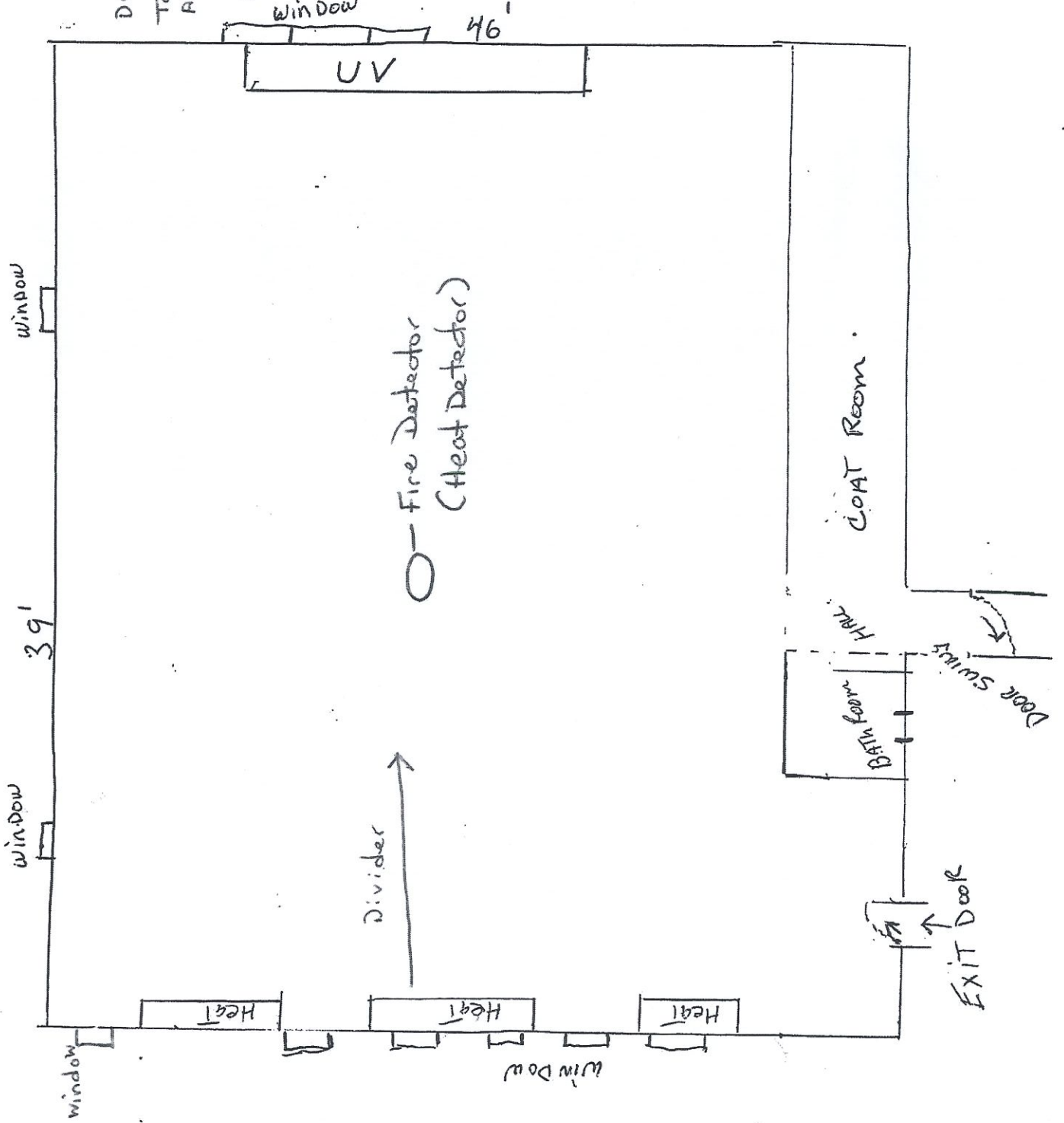

COOPERATIVE ICE HOCKEY AGREEMENT

THIS AGREEMENT made this 23rd day of May, 2023, by and between the Glen Ridge Board of Education ("Glen Ridge"), having offices located at 12 High Street, Glen Ridge, New Jersey 07028 and the Verona Board of Education ("Verona"), having offices located at 121 Fairview Avenue, Verona, New Jersey 07028.

WHEREAS, the New Jersey Interscholastic Athletic Association ("NJSIAA") authorizes cooperative sports programs pursuant to NJSIAA Bylaws, Article III, Section 7; and

WHEREAS, Verona has insufficient student participation for an independent Varsity Ice Hockey program; and

WHEREAS, Glen Ridge neither has a Varsity nor Junior Varsity Ice Hockey program for its students; and

WHEREAS, Glen Ridge and Verona have been in the past in a Cooperative Sports Program Agreement for Ice Hockey; and

WHEREAS, NJSIAA Bylaws provides that the duration of any such approved Cooperative Sports Program shall not exceed two (2) years before reapplication must be made; and

WHEREAS, subject to the approval of NJSIAA, Glen Ridge and Verona desire to continue the Cooperative Sports Program for Ice Hockey and enter into a new agreement allowing Glen Ridge students to continue to participate in Verona's ice hockey program;

NOW, THEREFORE, it is hereby agreed by and between the parties as follows:

1. **NJSIAA Application:** This Agreement is contingent upon Glen Ridge and Verona receiving approval from NJSIAA through submission of the NJSIAA Program Application for Cooperative Sports. If this Agreement is not approved by the NJSIAA, then this Agreement shall be null and void and of no force or effect.

2. Obligations of the Parties:

A. Verona shall serve as LEA/host district and Glen Ridge as the cooperating school district.

B. As LEA/host district, Verona's staff, including the Athletic Director and coaching personnel, shall continue to oversee the ice hockey program, including the scheduling of practice and games, as well as determining which students are on the ice hockey team. Verona shall also provide all necessary uniforms and equipment for the ice hockey program.

C. All Glen Ridge students who participate in the cooperative ice hockey program shall adhere to Verona Board of Education Policies and Regulations, including Student Code of Conduct; discipline; and academic and medical eligibility for participation in sports. Each Board shall be responsible for determining and confirming the eligibility of their respective student athletes to participate in the ice hockey program.

Transportation from Verona to ice hockey program events will be coordinated by the athletic directors in conjunction with the ice hockey program coaches. In the event Verona is unable to secure a bus, Glen Ridge's athletic director shall provide reasonable assistance to secure transportation.

3. Term/Renewal: This Agreement shall cover the 2022-2023 and 2023-2024 ice hockey seasons and shall commence upon its execution by both parties and approval from NJSIAA.

4. Costs:

A. For the 2022-2023 ice hockey season Glen Ridge shall pay to Verona \$35,718.42 for Glen Ridge's 50/50 participation in the ice hockey program. Payment shall be made by March 1st.

B. For the 2023-2024 ice hockey season and any extension of this Agreement except as otherwise negotiated and memorialized in writing at that time, the parties agree that Verona and Glen Ridge shall each be responsible for a proportional share of the total costs of the ice hockey program based upon the proportional share of each Board's respective students participating on the roster for the ice hockey program as of the prior school year's opening day for the ice hockey season, with a maximum cost share of 65% for any one team.

C. For each year of this agreement beyond 2022-2023, an initial payment for Glen Ridge's share of costs for each season shall be calculated based upon the total documented

cost for the ice hockey program during the prior school year, and shall be made to Verona no later than March 1st. After the completion of the season, additional payment may be required to account for differences in the actual costs of the ice hockey program in that year, and payment to account for such difference shall be made by April 1st.

- Pursuant to the allotment set forth in this Agreement, the parties agree that Verona shall be responsible for 35% of the costs of the ice hockey program for the 2023-2024 ice hockey season based on the distribution of the ice hockey program roster on December 8, 2022 (21 Glen Ridge participants and 7 Verona participants).

5. **Insurance:** Each party shall continue to maintain insurance coverage for their student athletes in limits not less than the maximum amounts of coverage maintained by each party and shall cause the other party to be designated on its policy as an additional named insured for purposes of this Cooperative Sports Program.

6. **Agency:** Except as expressly provided herein, no party shall have the authority to act on behalf of another party or to act as another party's general agent.

7. **Mutual Indemnification:**

A. Glen Ridge assumes all liability for, and agrees to indemnify and hold harmless Verona and its agents, servants, employees, students, guests, licensees and invitees, against any and all claims, losses, damages, injuries and expenses, including reasonable attorney's fees, arising out of, resulting from, or incurred in connection with, any acts or omissions by Glen Ridge, its agents, servants, or employees related to the performance of Glen Ridge's obligations under the terms of this Agreement, except for those claims arising out of the negligence of Verona, its agents, servants, employees, students, guests, licensees and invitees.

B. Verona assumes all liability for, and agrees to indemnify and hold harmless Glen Ridge and its agents, servants, employees, students, guests, licensees and invitees, against any and all claims, losses, damages, injuries and expenses, including reasonable attorney's fees, arising out of, resulting from, or incurred in connection with, any acts or omissions by Verona, its agents, servants, or employees related to the performance of Verona's obligations under the terms of this Agreement, except for those claims arising out of the negligence of Glen Ridge, its agents, servants, employees, students, guests, licensees and invitees.

8. **Merger:** This Agreement merges and supersedes all prior negotiations, representations and/or agreements between the parties relating the subject matter of this Agreement and constitutes the entire contract between the parties.

9. **Modification:** This Agreement may only be modified by an instrument in writing signed by both parties to the Agreement.

10. Waiver: No waiver by either party of any term or condition of this Agreement shall be deemed or construed to constitute a waiver of any other term or condition or of any subsequent breach, whether of the same or a different provision of this Agreement. Neither party may waive any of its rights or any obligations of the other party or any provision of this Agreement except by an instrument in writing signed by that party.

11. Severability: If any of the provisions contained in this Agreement are held illegal, invalid or unenforceable, the remaining provisions shall remain in full force and effect.

12. Notice. All notices pertaining to the Agreement shall be in writing, and delivered in person or sent certified mail to the parties at the following address:

A. **For Glen Ridge:** Business Administrator/Board Secretary, Glen Ridge School District Board of Education, 12 High Street, Glen Ridge, New Jersey 07028.

B. **For Verona:** Business Administrator /Board Secretary, Verona Board of Education, 121 Fairview Avenue, Verona, New Jersey 07044.

13. Governing Law: This Agreement shall be governed, construed and interpreted in accordance with the law of the State of New Jersey as it applies to contracts made and performed in New Jersey. The Superior Court of the State of New Jersey, in the County of Essex, shall have jurisdiction to hear and determine any claim or disputes pertaining directly or indirectly to the Agreement or to any matter arising therefrom. Each of the parties hereby expressly submits and consents in advance to such jurisdiction in any action or proceeding commenced by the other in such court.

14. Assignment: No party may transfer or assign any of its rights or obligations under this Agreement without the prior written consent of the other, and any such transfer or assignment or attempt thereat shall be null and void.

15. Section Headings: Section headings are for reference purposes only and shall not in any way affect the meaning or interpretation of any provision of this Agreement.

16. Counterparts: This Agreement may be executed in any number of counterparts, which, taken together, shall constitute but one instrument. It is not necessary that all parties sign all or any one of the counterparts, but each party must sign at least one counterpart for the Agreement to be effective.

17. Extension or Termination: This agreement will be subject to automatic renewal for up


to two years unless either party chooses to exit the program and end this relationship in its sole discretion. Either party may exit the program and terminate this Agreement by providing written notice to the other party received no later than April 1st of the prior school year.

- A. If either party exits the program after April 1st, it shall remain financially responsible for payments required under the terms of this Agreement for the following school year.
- B. If there are insufficient students interested in participating in the ice hockey program to constitute a full roster for any school year this Agreement shall be mutually terminated without further cost to either party.

18. Boards' Approvals: 18.19. The terms of this Agreement will not become effective until approved by both the Verona Board of Education and by the Glen Ridge Board of Education at respective public meetings of those bodies.
