




## COSMETOLOGY COSMETOLOGY COURSE OUTLINE

## COURSE Overview




### Upon completion of the course requirements the graduate will be able to


# COURSE Grading

## **Grading Procedures**

Students are assigned theory study and a minimum number of practical applications. Practical assignments are evaluated as completed and counted toward course completion ONLY when rated as satisfactory or better. Practical skills are evaluated according to the resource text procedures and performance standards established by the state licensing board.



## <u>REQUIRMENTS</u>: The requirements mentioned below must be met by each student in each category, in order to meet the minimum requirements and earned hours to be accepted by the State Board of Barbering & Cosmetology

- <u>50 hours/Orientation</u>: School rules, professional and personal development, professional ethics, employee and client relations, Public relations, business and salon management, record keeping and taxes, seeking employment and Sanitation and disinfection.
- <u>100 hours/Health and Safety:</u> Based on the State of California Board of Barbering and Cosmetology Health and Safety course, chemistry, anatomy, physiology, pH scale and salon safety.
- <u>100 hours/Disinfection & Sanitation</u>: Disinfection and sanitation in regards to the salon environment, client protection and safety, sanitizing procedures, disinfection procedures, bacteriology, understanding Universal Precautions, record keeping and State Board protocols for salon tools and equipment.
- <u>200 hours/Hairstyling Haircutting and Related Theory:</u> tools, appropriate use of tools, safe 8 proper hot tool handling, lines, angles, sectioning, haircutting and how it relates to the style, rollers, fingerwaves, pin curls, comb out techniques, formal styling
- 100 hours/Permanent Waving Chemical Relaxing and Related Theory: scalp and hair analysis, chemistry of cold waving chemical relaxing tools, procedures for all hair types, record cards and release forms and safety precautions.
- <u>100 hours/Hair Coloring and Related Theory:</u> understanding color theory. classifications of color, chemistry, color and bleach procedures, tools, techniques of color placement, corrective color, lash and brow tinting, record keeping, client release forms and safety precautions.
- 100 hours/Manicuring and Related Theory: Equipment, implements, products, types of services, related anatomy, disorders of the nail, massage manipulations, pedicuring, artificial nails, acrylic, gel and safety precautions.
- <u>200 hours/ Facials. Hair Removal and Lash and Brow Beautification:</u> Chemistry of cosmetics, structure and disorders of the skin, massage manipulations, brow arching, temporary hair removal, client record keeping and safety precautions.
- <u>50 hours/ Salon Business</u>: Fundamentals of business management, opening a salon, written agreements, licensing requirements, laws and regulations, salon operations, deductions, advertising, sales, communications and public/human relation
