SUPERINTENDENT WOODWARD

REFLECTIONS OF MY FIRST 100 DAYS

In my first 100 days as Superintendent of the Monroe School District, I've been honored to kickstart our collaborative journey toward shaping the district's future. During this time, I've had the pleasure of engaging with a diverse array of individuals and groups, including students, staff, families, community members, administrators, city officials, and civic & non-profit leaders. The input gathered through focus groups, meetings, emails, and surveys has been invaluable.

What We Heard



The feedback we received highlighted several key themes, including positive feedback about our schools, teachers, and dedicated staff, recognition of diverse alternative learning opportunities, and the strength of our high school athletics and extracurricular programs. There was also a strong desire to enhance safety and security measures, expand early learning opportunities, foster a greater sense of belonging for all, and reduce incidents of harassment, intimidation, and bullying.

Furthermore, the community expressed a need for increased access to our outdoor recreational facilities, the development of a strategic plan for our district, improved facilities, transparency, and regulation of student cell phone usage. There was also a desire to create more opportunities for community input.

What We've Done



Based on your input, we've taken immediate steps to address some of the concerns and suggestions. We've installed new security cameras, enhanced security measures at school entrances, and installed air quality indication monitors throughout the district. We will also be piloting vape detection devices at the high school level, with the intent to implement this at our secondary schools district-wide if we have positive results.

We've also opened up community access to Park Place Middle School track and fields, and added an additional Transition to Kindergarten program classroom (more info on these changes can be found on page 4-5). Furthermore, we've developed and are working on a district-wide goal to increase student belonging, and we've developed new resources on our website related to Harassment, Intimidation, and Bullying to reinforce how people can report incidents and how we respond to incidents district-wide.

Next Steps/ Strategic Planning



The insights we've gathered are guiding the development of our strategic plan. By mid-February, we plan to share a draft of our newly developed strategic plan and will be asking for your feedback before finalizing it and presenting it to the School Board for approval.

I look forward to further interactions with you as we continue charting a path for the future of the Monroe School District. Please reach out if you would like to schedule a meeting to discuss any issues, interests, or concerns related to our school district!

UNLOCKING RECREATION: COMMUNITY ACCESS TO OUTDOOR FACILITIES

During Superintendent Woodward's initial 100 days, community feedback highlighted a desire for access to district outdoor recreational facilities such as tracks, fields, and tennis courts.

In response to these requests, the track and all-weather fields at Park Place Middle School are now open for community use during non-school, daylight hours. The tennis courts at Monroe High School will also remain unlocked during these times.

We invite community members to enjoy our outdoor recreational facilities during non-school, daylight hours and when they are not

reserved for group activities. We kindly ask everyone to use these spaces responsibly, ensuring that we can maintain their availability for everyone. Please be mindful that any misuse or safety concerns may necessitate closure for the well-being of all users.

We opted to open Park Place Middle School's outdoor recreational facilities due to their clear visibility, providing a watchful environment to prevent misuse or safety issues. If the community's use of the facilities at Park Place Middle School is positive, we may explore the possibility of opening more facilities in the future.

EARLY LEARNING ACCESS EXPANDED WITH SECOND TRANSITION TO KINDERGARTEN CLASS

With the goal of increasing access to early learning opportunities for preschool-age students in our community, the Monroe School District is excited to announce a second Transition to Kindergarten (TK) classroom was added for the 2023-24 school year. This expansion is a direct response to identified community needs and a reflection of the district's commitment to providing a strong educational foundation through early learning.

Listening to Our Community

When Superintendent Shawn Woodward assumed leadership of the Monroe School District, he embarked on a journey to understand the district and its community better. Over the course of his first two months, Superintendent Woodward engaged in extensive dialogue with staff, students, families, and community members through focus groups and one-on-one meetings. One of the key issues that surfaced during these conversations: the lack of access to affordable, high quality learning opportunities for preschool-age children in Monroe.

This concern is not unique to Monroe; it mirrors a broader statewide issue. According to the Office of the Superintendent of Public Instruction (OSPI), a staggering 80% of preschool-age children in Washington do not have access to high-quality preschool programs.

The Transition to Kindergarten (TK) Program

To address this crucial need, OSPI introduced the Transition to Kindergarten (TK) program in the 2021-22 school year. TK is a pre-kindergarten program designed for children who are 4 years old and have been identified through a school district's screening process as needing additional preparation for successful kindergarten entry the following school year. This program is a vital step toward enhancing early learning opportunities.

TK programs, provided at no cost to families, are staffed by certified educators and fully integrated within the school environment. This includes access to meals, transportation, and recess, creating a comprehensive and supportive learning experience for young students.

Monroe's Commitment to Early Learning

Spearheaded by Melanie Gray, Principal of Salem Woods Elementary, the Monroe School District established its first TK classroom at Fryelands Elementary in 2021.

Recognizing the demand for increased access to preschool opportunities, and understanding that kindergarten readiness is a significant predictor of students' success on third-grade statewide assessments in math and English language arts, Superintendent Woodward made the proactive decision to open a second TK classroom this year.

This second classroom is located at Frank Wagner Elementary and quickly filled to capacity with students who were previously on the waitlist. The overwhelming demand highlights the community's readiness for access to more early learning opportunities.

The addition of a second Transition to Kindergarten classroom is a testament to Monroe School District's dedication to the educational well-being of its community. This expansion ensures that more children in our district have the opportunity to start their educational journey on a strong footing, setting the stage for a bright and successful future.

Each spring students in specific grades are assessed in Math, English Language Arts (ELA), and Science on state mandated tests. Student proficiency in each subject area is scored on a scale of 1-4, as follows: Level 1 = not at grade level standard, Level 2 = approaching grade level standard, Level 3 = meets grade level standard, Level 4 = exceeds grade level standard.


Percentage of Monroe School

GOALS FOR CONTINUED IMPROVEMENT

It is important to remember that state mandated tests only provide one data point each year. Our schools consider this data along with various other assessment scores, including class unit assessments and diagnostic assessments to evaluate student learning and plan for instruction and support.

While we are pleased to see that our students' scores on the state mandated tests have gradually improved over the last three years, we recognize that we still have much work to do. In an effort to continue this growth trend, we have set the following goals for improvement related to state mandated tests for the 2023-24 school year.

50.7% of students in grades 3-8 and 10 will meet grade level standards in English Language Arts (ELA) as measured by the Smarter Balanced (SBA) test in the spring of 2024.

39.1% of students will meet grade level standards in math as measured by the Smarter Balanced (SBA) test in the spring of 2024.

These growth goals were selected with the aim of being realistic and increasing our test scores to align with the average test scores for all school districts in Washington state.
