Grounds for Denying a Request to Sponsor a Guest

Mt. Diablo High School dances are for the students of the school. Outside guests are welcome by Permission only. Attendance at a dance is a privilege and not a right. Accordingly, the school reserves the right to approve the appropriateness of any guest at one of its dances or to deny admittance as a guest:

1. Any person who has been administratively transferred from Mt. Diablo High School or another district school for disciplinary reasons.
2. Any person who has been expelled from this district or, if it can be determined, from another school district.
3. Any person who has been disciplined for disruption or safety reasons at Mt. Diablo High School activities while they were a student at Mt. Diablo High School.
4. Any person identified as an associate or member of a gang as defined by police agencies.
5. Any person cited by the police for the following offenses: trespassing on school property; unlawful fighting; assault, battery; carrying weapons or displaying weapons and disturbing the peace, etc.
6. **Any person classified as a middle school student or who is over the age of 20.**
7. Any person whose character cannot be vouched for by school or police officials.

This must be signed by your MDHS Vice Principal before you may purchase your tickets.
