What is Title I?

Tips for helping your child at home.



- Read to your child everyday or encourage him/ her to read more and watch t.v. less.
- Talk to your child about his/her day.
- Make sure your child gets enough sleep every night. At least 8 hours is recommended.
- Make a quiet place in your home for your child to do homework.
- Encourage an attitude of the importance of daily attendance.

The Edgefield County School District receives Title I funds. These funds are used in our four elementary schools Johnston Elementary, Douglas Elementary, W.E. Parker Elementary, Merriwether Elementary, and J.E.T. Middle School. Title I is a federal program that offers supplemental funds to qualifying schools. To have a schoolwide Title I program, a school must have at least 40% of students receiving free or reduced lunch. Once a school meets this requirement, the funds can be used to add or improve programs for all students. The purpose of Title I is to provide resources to ensure

that all children meet challenging State academic standards in reading and math.

Title I programs generally offer smaller classes, additional teachers and assistants, additional training for school staff, extra time for instruction, computerassisted instruction and a variety of teaching methods.

- Books for classrooms
- Professional Development Opportunities
- Updated Technology

- Parent Resource Center Materials

Parents Right To Know

As a parent or guardian of a student in the Edgefield County School District, you have the right to know the professional qualifications for the teachers and instructional assistants who instruct your child. Federal law allows you to ask for certain information about your child's classroom teachers and requires us to give you this information in a timely manner.
