Part I. Chatfield Public Schools ISD #227 Mission Statement emphasizing Parental Involvement

During this time, parents will be informed of our current plan and are welcome to provide feedback on improving the program.

2. How will the district involve parents in the joint development of the Title I plan?

Parents are involved in the development of the Title I plan in several ways.

- a. During our fall open house, parents can visit with our Title I teacher where she receives input and lays out the current year plan and programs.
- b. Parents are also invited during conferences in October and February to visit with our Title teacher and again have an opportunity to visit about programming.

 - 3. How will the district inform parents of the school report card?

The school report card is discussed at the October school board meeting each year. The meeting is a public meeting, but is also aired on Chatfield's Closed Circuit television channel. 4. How will the district notify the parents that the district has been identified that it needs improvement?

Our school will continually strive to improve, but is not currently identified as a district in need of improvement. We will inform parents via the usual channels as the need arises.

Assistance will be provided to parents during open house in September and conferences two times a year. Students and parents will be asked to dedicate a half an hour to reading each night. Teachers will provide parents with goals specific to each child's reading levels.

10. Chatfield Public Schools ISO #227 will, with the assistance of its Title I schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent involvement.

During our Parent Teacher Conferences, Title I Staff will provide opportunities for parents to receive information and training on our literacy program and Title One Supports. Elissa Johnsrud is our contact person for our literacy program and Anna Olson is our contact person for Title I Services. Both individuals can be reached at 507-867-4521.

11. Chatfield Public Schools ISD #227 will, with the assistance of its Title I schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools.

We plan to involve all school personnel with formal training during our PLC meetings and Wednesday morning late starts. Topics of discussion will include the following:

Session 1: What is parent involvement and why is it important? Overcoming obstacles and barriers to parent involvement. Working together for improved parental involvement practices.

Session 2: What do we know about parents? Let's talk: family-school communication. What's working in parent involvement? (And what's not working?)

12. Chatfield Public Schools ISD #227 will coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children.

The elementary school works closely with our Early Childhood Family Education coordinator and serves on the advisory committee. We have coordinated our Action 100 literacy program with our community education preschool program. Parental involvement activities are planned. There is a Fall Arts Festival scheduled for September, a Winter Fest will be scheduled in December (date TBD, depending on Winter concert schedule), and a Spring Event will be scheduled in May (depending on Spring concert schedule) for ECFE, where parental involvement activities including make and take projects are planned. 13. When students are selected to receive Title I services, information about the program, selection process, parental rights, and other applicable facts are sent home to families. The Title I Teacher, Anna Olson, is also available via email, phone, or scheduled in-person meetings if parents have specific questions. The school also advertises events and Title I information on the school Facebook page and on the school website. We also send flyers home with students to advertise events. 14. Each year in March the Title teacher, Anna Olson, and the paraprofessionals who serve students meet with the principal and a parental advisory committee to review the current plan, make revisions, and begin planning for the following school year. Being a small community, we know our parents very well and are able to accommodate individual needs quite well. We have only a few parents who speak Spanish in the district. We ensure they have documentation written in Spanish for them to review. We also make efforts to verbally communicate with parents who have poor literacy skills themselves.
