A new teacher, Olivia Borchers, has been hired for an upper elementary class. There will be an additional 4th grade section next year making 4 sections. There will be one more teacher hired for upper elementary for next year.

We have some scheduled field trips coming up for many classrooms.

5th grade award ceremony will be Tuesday, May 25th. Classroom teachers will be sending more information soon.

Camp Edventure starts June 7th. There are 122 students enrolled. We will have 10 sections of classes. SEL (Social Emotional Learning) clinicians will be added to the program this year.

We are finalizing the FFV (Fresh Fruit and Vegetables) program for next year. We will likely receive this program again next year.
