## **Parental and Family Engagement Policy**

Tunica Elementary School developed this written Parental Involvement Policy that meets the requirements of Title I NO CHILD LEFT BEHIND with input from parents. Tunica Elementary School will provide the School Level Parental Involvement Policy in an understandable format and language for all parents during the month of September.

I. Involvement of Parents in the Instructional Program

Tunica Elementary School will:

- A. Hold an annual meeting at a convenient time, for all parents of participating children. The purpose of these meetings is to:
  - · Inform parents of their school's participation in the Title I program.
  - · Explain the requirements of Title I.
  - Explain the Rights of Parents to be involved.

B. Provide a flexible number of meetings in the mornings and evenings for parents to attend. The following meeting and activities will be available:

D. Develop and maintain consistent, effective communication between home and school.

G. Provide parents, if requested, the opportunities for regular meetings to make suggestions and to participate, as appropriate, in decisions relating to the education of their children.

#### II. Student-Parent-Teacher Compact

- · Tunica Elementary School Newsletters
- C. Provide parents with information regarding the qualifications of teachers:
  - · Teacher's qualifications to teach subject matter
  - · Type of credentials held
  - · Degree or graduate certificate held

· If services are provided by a paraprofessional, what type of services and the paraprofessional qualifications

D. Parents are given monthly opportunities to give input and suggestions about programs at Dundee Elementary School and the Parent Liaison will share information with the administration. A parent survey is conducted on a yearly basis and the data is shared with all stakeholders.

E. Coordinates and integrates parental involvement with other programs and provides other activities, such as opening a Parent Resource Center three times a week to encourage and support parents in more fully participating in the education of their children.

F. Distributes, to parents, information related to school and parent programs, meetings, and other activities in a format and language that parents understand.

G. Provides support for parental involvement activities by parents.

F. The ways in which the programs will meet the objectives of an individualized education program for a child with disabilities.

G. The right of the parent to decline enrollment, request the child be moved from the program offered or receive help in choosing another one.

V. Tunica Elementary School provides opportunities for all parents to participate, including parents with limited English proficiency, parents with disabilities, and parents of migratory students. Accommodations will be available for all parents attending meetings.

This Parental Involvement Policy has been developed jointly with, and agreed upon with parents of children participating in Title I Programs, as evident by meeting minutes.
