Funds raised will help is increase the amount we can spend on the playground and provide funds for ongoing maintenance. The district maintenance director has been looped in to help with equipment/surfacing choices since they will require long-term maintenance.
- **b.** Leah formally requested that the playground committee be a standing committee for PTO and maintain a budget. This status will show an ongoing commitment to the space. Allison and Leah will be the current chairs.
