 - 1. Several years ago, a committee was formed and was working with Rock Hill and a playground company. COVID hit when the committee was going to talk with the city in 2020 and efforts were delayed. The playground grant that would provide funding for the Hudson playground is still available. A new playground committee was formed and is working with Rock Hill, the Webster Groves School District and Mrs. Hilpert. The committee is now getting the word out to the Hudson community, Rock Hill and Warson Woods. The committee is working with Rock Hill because there is a municipality grant available that provides \$315,000 for the project. The committee needs 5% of the total grant or approximately \$16,000 to apply for the grant. They are working with the city to apply for a planning grant to work with an architect (landscaping) and to help with public hearings. The committee needs \$8,000 by January for the planning grant (of which \$6,400 will be refunded). The playground fund currently has \$5248 so need to raise approximately \$12,000 more to accomplish the grant submission goals. The committee is trying to raise the funds now for this playground project prior to the current playground needing major repairs.
