



**NOTICE OF ACTION
STATE ENVIRONMENTAL POLICY ACT**

**BETHEL SCHOOL DISTRICT NO. 403
EVERGREEN ELEMENTARY MODERNIZATION AND ADDITON
PROJECT**

Notice is given under the State Environmental Policy Act, RCW 43.21C.080 and in accordance with Bethel School District Board Policy and Procedure 6890, that Bethel School District (the "District") No. 403 took the action described in (2) below on February 2, 2024.

1. Any action to set aside, enjoin, review, or otherwise challenge such action on the grounds of noncompliance with the provisions of chapter 43.21 RCW (State Environmental Policy Act) shall be commenced on or before March 20, 2024.
2. Description of Agency Action: Bethel School District, as lead agency, retained that certain Determination of Non -Significance issued by Bethel School District on February 2, 2024, as modified relating to the proposed Evergreen Elementary School Modernization and Addition Project. The District, through its Superintendent, directed the Director of Construction and Planning for the Project to proceed to obtain all necessary and required permits and approvals for the Proposal under and associated with the Evergreen Elementary School Project.
3. Description of Proposal: The proposal is to modernize and construct a new 8,929 square foot addition to the existing Evergreen Elementary School. The project includes 8-10 new classrooms, a new kitchen and commons, remodel of existing administrative areas and general building upgrades including but not limited to building systems and finishes. Frontage improvements will be included as required by Pierce County Planning and Public Works. The project will include the removal of (3) existing portables to accommodate the project including a new play shed.
4. Location of Proposal: The existing Evergreen Elementary School is located at 1311 172nd Street East, Spanaway, WA 98387. The school is located on Parcel No. 0319273068.
5. Type of Environmental Review under SEPA: SEPA Environmental Checklist, dated November 9, 2023, and Determination of Non-Significance, issued February 2, 2024.
