This month, we would like to recognize a South Shore student who worked hard to achieve ▲ a goal. Sophia "Sophie" Truchon, who is in 9th grade, represented South Shore in Wisconsin Rapids for the State Cross Country Meet! Qualifying for state is a HUGE accomplishment, and is the result of dedication and hard work. South Shore students and staff held a special assembly with games, words of encouragement, and laughs to send Sophie to state feeling the love and support of her school community.



Sophie began running when she was in the 6<sup>th</sup> grade. She told me she had no idea whether she would be "even a little bit good at running", and she only started because her siblings did. As it turns out, she is more than "a little bit" good at it! All summer Sophie ran five days a week to get ready for the cross country season. She trained and pushed herself to keep up with her brother Daniel, who is also an accomplished runner. Sophie says her best accomplishment this season was reaching her goal of running a 5K distance in less than 21 minutes. Sophie also had a fantastic run at the state championships and finished 61st out of 152 girls with a time of 21:06. Beyond speed and personal records, Sophie quickly learned that running is just as good for her mind as it is for her body. On a hard day, a run is a great and healthy way for her to handle stress.

Sophie is an excellent student with a kind heart. She

loves her dog Max, enjoys art and drawing, sewing, pasta, reading and quiet time. Church and her faith are a very important part of who she is. When I asked Sophie if there is anything she would want me to say on her behalf, she shared how grateful she is to her coaches, Coach



Lahti and Coach Hoagland, and to her mom and dad. These adults have all encouraged her and been there for her to help her achieve her goals. She also wanted to give a special thank you to the whole cross country team for their friendship and encouragement.

#### **CESA #12 Coach Visits Classrooms**




Last week we had Diamond, a coach from CESA #12, in our classrooms observing instruction and providing feedback on best practices that impact student learning.


