



Comprehensive School Safety Plans (CSSP)

CSSP. Requirements

Education Code 32280-32288

Requires every school to develop and maintain a CSSP designed to address campus risks, prepare for emergencies, and create a safe, secure learning environment for students and school personnel.

The law requires that CSSPs be reviewed and updated per school annually and it requires adoption of the plan by March 1st of each school year.

Required components include:

- Assessment of school climate and local crime
- Child abuse reporting procedures
- Discrimination and harassment policies
- Suspension and expulsion policies
- Policies for maintaining a safe and orderly environment
- Safe ingress and egress procedures
- Disaster response procedures

Comprehensive school safety plan material is typically derived from Education Code (Ed Code), Board Policies (BP), Administrative Regulations (AR), and partner resources and input.

Fair=75%-89.99% of standards,
Poor=0%-74.99% of standards.

CSSP. Disaster Drills

Practice

In California, schools practice drills for:

- Earthquake: (i.e. Great Shake Out) by ducking, covering, and evacuating.
- Fire: by testing the fire alarm and practicing evacuation.
- Lockdown/Lockout: (for danger outside, suspect on loose, etc.)

Disaster Service Workers

- All public employees are included in the disaster service worker status, whether employed by a county, city, state agency, public district or schools.
- Public employees may be activated as disaster service workers any time there has been a declared disaster.



CSSP. Response Actions



Lockout

The perceived **DANGER IS OUTSIDE** of the school. Staff move all students and activities inside and ensures the building perimeter is secured and locked. Normal classroom activities are maintained with minimal interruption or distractions (i.e. nearby police activity).



Lockdown

The perceived **DANGER IS INSIDE** or very near the school. Doors are locked, lights are turned off, and students and staff move to a safe location. Students are to remain quiet (i.e. intruder; run, hide, fight).



Evacuation

Students and staff **EVACUATE** to a safe location due to a situation in or near the school building. Plans are available in each classroom and offices. Evacuation may be necessary after a natural disaster (i.e. fire, earthquake).



Shelter

Students and staff are instructed to **TAKE SHELTER** due to a situation in or near the school. Shelter may be necessary where evacuation is not recommended (i.e. external health hazard).

CSSP. Updates



Active Shooter Training

8 out of 10 completed.



Canine Visits

Have started visits at middle schools.



IP Speaker Clock System

Project complete at all school sites. Message templates setup and training completed at each site.

New Emergency Items

New backpacks were delivered to all sites. Lockdown buckets are replenished based on use.



New Emergency Flip Charts and At A Glance posters

Distributed to all sites.



Partnership with South LA & Lawndale Sub Station

Site assessments and walks of campuses completed.

Follow up active shooter training

More training to be provided being designed to include Management of Aggressive Behaviors (MOAB).



Naloxone (Narcan)

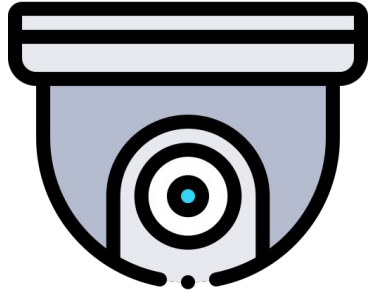
Distributed to all sites.
