Ms. Michelle Hubbard motioned to approve Jada Elmore to serve as an Attendant from R.J. Rhodes Transit for the 2017-2018 school year (clearances are on file). Mrs. Annette Hubbard seconded this motion and it was unanimously approved upon a roll call vote.

BEAVER VALLEY INTERMEDIATE UNIT:

It was necessary to appoint one Board Member to serve as the Delegate Representative and one to serve as the Alternate Representative for the Rochester Area School District on the Beaver Valley Intermediate Unit's *Beaver Valley Joint School Committee* to serve for a one (1) year term. The Committee meets annually in December. Annette Hubbard nominated Dennis Iannini as the Delegate and Marian Acon nominated Annette Hubbard as the Alternate. This was approved by motion of Mrs. Acon, second of Michelle Hubbard and unanimous roll call vote.

It was also necessary to appoint one Board Member to serve as the Delegate Representative and one to serve as the Alternate Representative for the Rochester Area School District on the Beaver Valley Intermediate Unit's PSBA/BVIU Legislative Action Council to serve for a one (1) year term. Annette Hubbard nominated Brian May as the Delegate and Michelle Hubbard nominated Floyd Tame as the Alternate. Mrs. Acon motioned and Mr. Blackwell seconded this motion that was then unanimously approved upon a roll call vote.

BEAVER COUNTY CAREER AND TECHNICAL CENTER:

Mr. Tame nominated Mr. George Bauer to serve as the Delegate Representative, and Michelle Hubbard nominated Mr. Brian May as the Alternate Representative for the Rochester Area School District on the *Beaver County Career and Technical Center's Joint School Committee* to serve for a three (3) year term. Mrs. Acon motioned to approve the aforementioned and Ms. Michelle Hubbard seconded this motion which was then unanimously approved upon a roll call vote.

Mrs. Acon motioned to approve Christine Kronk as Delegate Representative, and Larry Blackwell as Alternate Representative for the Rochester Area School District on the Beaver County Career and Technical Center's *Citizens Advisory Committee* to serve for a three (3) year term. The Committee meets semi-annually in November and April. Annette Hubbard seconded this motion and it was unanimously approved upon a roll call vote.
