PUBLIC PARTICIPATION ON NON-AGENDA ITEMS:

Mr. Benjamin Palmer presented a very detailed report regarding the failure of busses to be on time during the single digit degree temperatures on two occasions for his son and daughter who are in the 6th and 3rd grades respectively and other children of the community. He said he had called the school several times and finally spoke with Ms. King, Superintendent's Secretary, who on one of the occasions went to the elementary school to find his children and the children of two other parents as they were on their way to pick them up and didn't want them to get on the bus. However, when Ms. King arrived at the Elementary the children had already gotten on the bus which had arrived late and she told the parents that she had not been able to get there soon enough to detain them. The parents then went to the bus stops to get their children. Mr. Palmer was requesting that the school have a better system of letting the parents know immediately when the busses are going to be late in order that the students are not standing out in that kind of weather for a long period of time. Dr. Bovalino assured Mr. Palmer that they would do their best to rectify this problem.

INFORMATION:

At this time Mrs. Acon reported that there had been an incident on January 6, 2018 at the school involving Officer Hacker, the School Resource Officer, who was reportedly acting out of the ordinary while on duty at the school. The officer is employed by the Township and has been suspended pending their investigation. He has not been on duty at the school since the time of the incident. Dr. Bovalino assures all that no students were put in any danger at the time of the incident. The District is cooperating with the Township in their investigation. However, as this is a personnel matter we are not at liberty to comment on this issue.

ADJOURNMENT:

There being no further business for this evening Mr. Tame motioned to adjourn this meeting to go into an executive session at 7:37 p.m. after which there will be no voting. The executive session ended at 8:15 p.m. with Mrs. Annette Hubbard seconding this motion and it was unanimously approved upon a roll call vote.
