#### TEACHERS AND PERSONNEL

- 1. Recommend approving Allison Seezox (1 day a week) to serve as a teacher in the Elementary DARE2XL Tutoring Program for Grades 1-5, at a rate of \$25 per hour. The program runs Mondays through Thursdays, from 3:20 4:50. Teachers will receive an additional \$3/hour for continuous time served with the program.
- 2. Recommend approving Abbey Matiko and Sherri Verrico as Paraprofessionals to serve in the Elementary DARE2XL After School Program for our students in grades 1 5. The program runs Mondays through Thursdays, from 3:20 4:50. TAME will compensate Paraeducators based on their contractual rate, plus an additional bonus for time served with the program.
- 3. Recommend approving the following field trip(s):
  - a. October 19, 2023 Grade 12 students to attend New Brighton High School to visit the College Fair.
