CORRESPONDENCES TO COME BEFORE THE BOARD:

Dr. Bovalino reported that in an article that appeared in the Sunday, August 1, 2021 edition of the Beaver County Times, it was reported that our school board had voted to raise taxes. SUPERINTENDENT'S REPORT:

Dr. Bovalino extended congratulations and special thanks to Kathy Onuska on receiving the competitive Fresh Fruits and Vegetables Grant for our Elementary School for the 2021-2022 school year! The total grant awarded is \$20,215 and must be spent by June 30, 2022.

It was also reported by Dr. Bovalino that the staff and students are beginning to return to the building. Teachers are completing their rotating clerical day throughout the week. Our football team and cheerleaders have been onsite – completing heat acclimation and such. She stated, "It is great to hear everyone in the halls and around the campus as we work!"
