#### COMMITTEE MEETINGS, 6:00 p.m.

The Board assembled for their committee as a whole meeting at 6:00 p.m. on Monday, February 23, 2023.

#### **FINANCE**

The Board reviewed Mr. Bruce Senior's request to return the penalty phase of his taxes, an amount totaling \$101.72. After a great deal of discussion, the board decided that they would not reimburse Mr. Senior for the fees. Various reasons were cited including setting precedence, 72 P.S. § 5511.7, which states the failure to receive a tax bill does not relieve a taxpayer of the responsibility to pay their taxes in a timely manner and 53 P.S. § 6924.706, which states that the school district does not have the authority to waive a late penalty as it is statutorily imposed. The Board also discussed that they have no way of knowing why the tax bill was not delivered by the postal service.

#### FLOURISH BEAVER COUNTY

Discussion ensued regarding selecting a representative for the Flourish Beaver County Board. The RASD Board of Directors chose to nominate RASD Board member Jocelyn Haskins.
