Sequatchie County District Family Involvement Plan School Year

- 1. The Sequatchie County Board of Education will take the following actions to involve parents in the joint development of its district wide parental involvement plan under section 1112 of ESEA:
 - A. Parents will be included on District committee as well as school committees.

 - A. Parents participate in after school and summer programs in Title I Schools. Parents are invited to do demonstrations and presentations about careers/hobbies. Also, parents and community are invited guests for performances.
 - B. Extended Contract Teachers encourage parent participation in their programs.
 - C. Parents and Civic Groups are welcome to utilize the school and Board of Education buildings for meetings such as TN Tech Master's classes, ABWA, Southeastern SPED supervisor meetings, and Chamber meetings, etc.
- 5. The Sequatchie County Board of Education will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disable, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). - C. The Board of Education will give parents an opportunity to discuss and have input in assessments of the parent involvement program and needed changes, through meetings, open house, PTO, surveys, e-mail, and telephone opportunity.
 - 1. The effectiveness of the policy in increasing parent participation will be through the end of the year survey to determine what changes are needed to allow more parent input and participation.
 - 2. The Board of Education will also identify barriers to participation of parents, such as time of meetings, need of transportation, child care, and language differences; and discuss ways to try to improve these problems.
- 6. The Sequatchie County Board of Education will build the schools' and parent's capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:
 - A. The school district will, with the assistance of its Title I, part A schools, provide assistance to parents of children served by the school district, or school, as appropriate, in understanding topics such as the following, by undertaking the actions described in this paragraph.
 - 1. Each Title I school will explain test results at the annual Open House.
 - 2. Progress reports will be sent to parents at the end of each six (or nine) weeks grading period.
 - 3. Parent Teacher conferences may be scheduled at the request of the teacher or parent.
 - 4. Teachers attending workshops/conferences paid for by federal funds will offer parent and /or teacher training sessions after they return. This way information obtained at the workshop/conferences will be shared with faculty and parents
 - B. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology as appropriate, to foster parental involvement by:
 - 1. Providing links on the district web page on additional resources to help students succeed.
 - 2. Provide parents the e-mail addresses of teachers in the school their child attends at the beginning of each year.
 - C. The school district will, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

 - D.
