- Bullying Matrix, discussion topics that are shared with parents was presented. Categories of Conflict, Rude, Mean, Bullying so there is a greater understanding of what constitutes bullying.
- Proactive Approach
  - Teachers complete a course on Bullying: Recognition and Response
  - Positivity Project twice a week (character education)
  - WEB leaders (Where Everyone Belongs)
  - Try to avoid situations escalating to a bullying situation by check-ins, discuss bullying matrix, practice using assertive language, discuss choices to act mean or act differently.
