North Carolina Final Exam Requirements

This memo serves as guidance for the North Carolina Final Exams (NCFE) requirement for Exceptional Children.

In accordance with State Policy and Federal Law, North Carolina's statewide testing policy requires all students with disabilities to participate in the statewide testing program by taking the general state-mandated tests with or without accommodations; or, by participating in the North Carolina alternate assessment with or without accommodations. Currently, the only alternate assessment option in North Carolina is the NCEXTEND1, which requires participating students to meet the eligibility criteria established by the NCDPI. Students who previously participated in the NCEXTEND2 will take the general state-mandated tests with or without accommodations in compliance with their IEP.

Students who are currently following the Occupational Course of Study (OCS) will participate in the NCFE, in the required courses, as indicated in the attached chart. This policy is in accordance with IDEA and NCLB.
