



## FINANCIAL INFORMATION 2024-2025

### TUITION AND REGISTRATION/ENROLLMENT

<b>ONE TIME ENROLLMENT FEE: \$800.00</b>	<b>DUE MARCH 13, 2024</b>
<b>TUITION FOR 2024-2025 : \$10,900.00</b>	Direct payment in full, one-half payment or FACTS account setup must be completed by <b>MAY 3, 2024</b>

### TUITION PAYMENT OPTIONS

<b>1. PAY IN FULL (3 OPTIONS)</b>	<ol style="list-style-type: none"> <li>1. Issue a <b>check</b> payable to "Mount Carmel Academy." <b>2. TWO INSTALLMENTS (3 OPTIONS)</b>	<p>First installment of \$5450 due May 3<sup>rd</sup>; Second installment of \$5450 due November 3<sup>rd</sup>.</p> <ol style="list-style-type: none"> <li>1. Issue a <b>check</b> payable to "Mount Carmel Academy." Attention: Finance Office via mail or hand deliver to school.</li> <li>2. Create a <b>FACTS account</b> to process these two payments.</li> <li>3. <b>Credit card</b> payments NOT processed through FACTS, call the finance office at (504)288-7626 x 2340. (There will be a processing fee of 2.95%)</li> </ol>
<b>3. TEN EQUAL INSTALLMENTS *</b>	<p><b>Set up a FACTS account with a choice of a monthly due date of the 1<sup>st</sup> or the 15<sup>th</sup> starting in July and ending in April.</b></p> <p>This payment plan will have a FACTS fee of \$50.00 which will be processed when you set up your FACTS account. Late Fees of \$25.00 per month will be assessed when deemed necessary.</p>

A family who chooses the 10 installment payment plan is required to set up an account with FACTS where you can pay in one of the following ways:

- Direct debit from your checking account.
- Debit card – which will include a convenience fee of 2.95%.
- Credit card – which will include a convenience fee of 2.95%.

### STUDENT INSURANCE

The Student Accident Plan is a program designed to reimburse parents/guardians for out-of-pocket expenses incurred from hospital, physician, and other medically necessary eligible expenses which occur as a result of an accident to their dependent child who is a full-time registered student in a school which has agreed to participate in the Religious and Charitable Risk Pooling Trust. The Plan is an "Excess" Plan over other valid coverage. Your family medical insurance is "Primary". If the parent/guardians are employed, but have no insurance, we must receive a letter to that effect on the employer's letterhead. If the parents can prove that they could not be covered by an employer sponsored plan, or unemployed with no access to coverage, then the student accident plan will be primary.

## ADDITIONAL COSTS

**STUDENT FEES** - Fees vary from student to student with fee bills ranging from \$800 to \$900.

**Fees include:**

1. Course Fees are determined by individual student schedules
2. Driver's Education fee for Freshmen classroom instruction. Behind the Wheel fees are not included.
3. All books and E-books will be purchased either through BNC Online store or the fee bill.
4. Detailed information about ordering textbooks online will be sent to you.
5. Please note that supplemental reading books may be obtained from other students or another source.

**Fee payments:**

1. Mid-summer families will be emailed a listing of all fees to be paid via a QuickBooks Invoice.
2. All fees must be paid prior to the first day of the school year in order for a student to begin the year.

**STUDENT ACTIVITIES** - There are other events/activities that may increase your costs, such as belonging to an athletic team, dance team, cheerleaders, dues for various organizations, smaller scale events and the school-sponsored dances and proms. These are determined by your choice and degree of participation. If a club or team chooses to travel, travel expenses are not provided by the school.

## ADDITIONAL FUNDRAISERS

- Fall Raffle — Each student is required to sell seventy-five (75) tickets for the chance to win a prize of \$10,000 cash.
- Gift/Gift Wrapping Drive — Student Council fundraiser. Each student is requested to participate.
- Easter Candy Sales — Student Council fundraiser. Each student is required to sell \$60.
