- Maintaining a Parent portion in our website, which provides guidance and detailed information regarding school and curriculum matters within each grade or resource used

Report academic progress to parents via:

- Services such as Remind, School Reach, or similar
- School website postings

• Regular emails via the school's LMS or similar (Schoology, Skyward, etc.)

- Annual Title I meetings held during the first quarter, where families will be informed of the school's Title I program, budget, and their right as parents/guardians to be involved in their child's education

Facilitate and encourage parent participation and suggestions in decision making at our school via:

- Inviting parents to participate as members of the School Council, including
  - participating in the development of the Campus Improvement Plan (CIP)
  - reviewing and approving the annual Title I Parent-School Compact
  - reviewing the Parent/Family Engagement Policy and Procedures for Harmony

- Individual conversations with Academic and/or Behavioral counselors as needed.

- Participating in competitive athletic and academic events, organized by the campus or district
