### Plans for Spending

On November 8, 2022, California voters approved Proposition 28: The Arts and Music in Schools Funding Guarantee and Accountability Act. The measure requires the state to establish a new, ongoing program supporting arts instruction in schools beginning in 2023–24. The amount of funding available each fiscal year for the Arts and Music in Schools (AMS) program will be one percent of the K–12 portion of the Proposition 98 funding guarantee provided in the prior fiscal year, excluding funding appropriated for the AMS program. Each school will have the autonomy to decide which arts education programs they wish to offer. In this decision-making process, school leaders will collaborate with teachers, families, and students, ensuring that the choices made best serve the unique needs of their local school community.

The funds from Proposition 28 can be utilized for a wide range of arts education purposes. These include, but are not limited to, providing instruction and training, acquiring necessary supplies and materials, and establishing partnerships with arts organizations for enhanced educational programs. The supported art forms include dance, media arts, music, theater, and visual arts, which may involve folk art, painting, sculpture, photography, craft arts, creative expression (such as graphic arts and design), computer coding, animation, music composition, ensembles, script writing, costume design, film, and video. Prop 28 funding is intended to expand existing arts education at all school sites. The majority of the music that will be taught is through the use of recorders and percussions with a focus on our 4th grade population of 600 students district wide. Currently the plan is to hire 3 additional FTE teachers for music and art. These teachers will service all 11 schools in our district from 4th grade up with approximately 3,019 4th – 8th grade students, supplementing our current music and art program with the use of additional classified or teacher aides.

#### Educational Partner Feedback:

Based on the 2022-2023 Parent Survey of over 1300 responses:

- 99% Agree/Strongly Agree with the statement: "In addition to English Language Arts and Mathematics, it is important for my child to have instruction in Science, History, Art, Music, and Physical Education."

Based on the 2022-2023 Student Survey of over 1800 responses:

- 77.27% Agree/Strongly Agree with the statement: "I think it is important to have music at my school."
- 80.83% Agree/Strongly Agree with the statement: "Participating in band enriches (improves) my experience at school."
- 70.43% Agree/Strongly Agree with the statement: "Participating in band motivates me to come to school every day."
- 78.10% Agree/Strongly Agree with the statement: "Being a part of band at school will help me in the future."
- 59.83% Agree/Strongly Agree with the statement: "Participating in art motivates me to come to school every day."
- 65.91% Agree/Strongly Agree with the statement: "Participating in art enriches (improves) my experience at school."
- 60.27% Agree/Strongly Agree with the statement: "Learning about art will help me in the future."

Beginning in the 2023-2024 school year, funds pooled with other district school sites, will be used to hire certificated music and art teachers to supplement our current music and art programs. This will result in more of our students at a lower grade level, having access to performing arts through music and art. A maximum of 20% of funds will be used to purchase supplies to support the music and art programs.

Each school is required to submit an annual board-approved report to be posted on the school district's and Department of Education's websites that details the type of arts education programs funded by the program; the number of full-time equivalent teachers, classified personnel, and teaching aides; the number of pupils served; and the number of school sites providing arts education programs with such funds.
