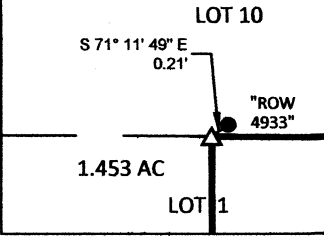
DETAIL "A" NOT TO SCALE



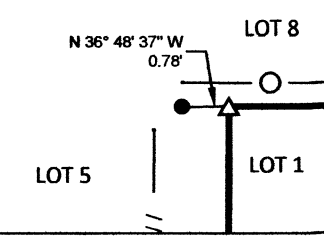
DETAIL "B" NOT TO SCALE



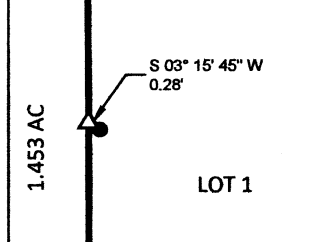
DETAIL "C" NOT TO SCALE



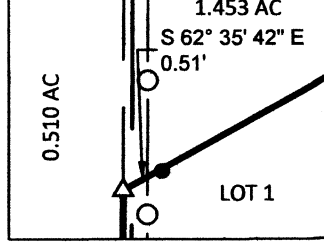
DETAIL "D" NOT TO SCALE

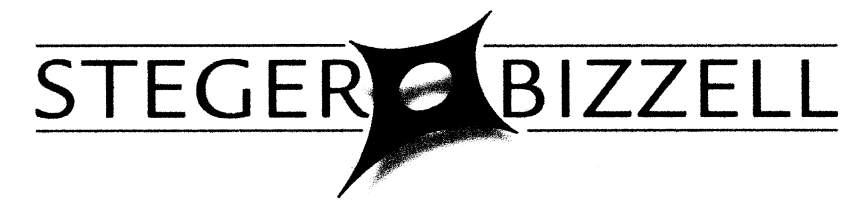
