2024 - 2025 Kindergarten Registration

February 26th, 27th, 28th and 29th

9:00 - 11:45 A.M. and 1:00 - 2:15 PM ~ By appointment only

The Maywood School District is now accepting registrations for incoming kindergarten students for the upcoming 2024-2025 school year. Kindergarten registrations will be in person. Registration forms can be found online and printed at home for your convenience. Parents also have the option of stopping by Memorial School and picking up the registration packet. The Memorial School office hours are 8 am to 4 pm Monday through Friday.

Please call Memorial School at 201-845-9113 extension 8 to schedule your 15-minute appointment.

To Register Your Child in the Maywood Public School Kindergarten Program:

- You must be a resident of Maywood and provide four proofs of residency.
- Children are eligible to register if they turn 5 on/or before October 1, 2024.
- The child wishing to attend Kindergarten must be living with you, the parent(s).

Please submit the following documents:

- Your child's original birth certificate or passport
- Four proofs of residency (Please see list below)
- Genesis Open Registration Form
- ESL Home Language Survey
- District Media Consent Form
- One recent photo of your child
- Immunizations Record
- Health History Questionnaire
- Physical Examination Form - Current for the upcoming school year.
- Medical Confidential Form
- If applicable, please also present custody or court documents.

Please visit our website at www.maywoodschoools.org to begin the registration process and enter your information. Click on the "Parents" tab on the home page. then scroll down to "New Registrations" and click on the link "Genesis Open Registration". Add information. Please note that you must register in the 2024-25 school year.

The state requires that parents/guardians of any pupil attending public school submit documentation that the child has the mandatory

immunizations. Documentation means a written statement from a physician, clinic, or an official school transcript, which lists immunizations, and the specific dates each was given. If the school is unable to translate foreign immunization records, it will be the responsibility of the parent/guardian to secure English translations of those medical records by a physician. All immunization records must have the physician's signature stamp.

Children will not be permitted to enter school in September without all medical requirements being met. If your child is already enrolled in our present kindergarten program, it is not necessary to re-register for first grade.

Documents Required for Registration

FOUR (4) proofs of residency AND your child's original birth certificate with the raised seal or Passport. The proof of residency must have the last name noted on the proof. A photo ID is also required.

Homeowners must provide at least one of the items in bold plus 3 additional proofs. Tenants must provide at least one of the items in bold plus 3 additional proofs.
