



Scott Thomas Basketball Camp July 11 & 12 Thursday/Friday Grades 3-8

Former Buckeye Valley Baron, BGSU Falcon and professional basketball player Scott Thomas will host a two-day skills camp on Thursday and Friday, July 11th and 12th at Buckeye Valley High School for boys and girls going into grades 3 through 8.

Camp focuses on shooting, ball handling, rebounding, passing and offensive moves. Participants receive instruction from Scott, coaches, former collegiate players and professional players. Players registered by June 15 will receive a camp t-shirt. Campers will enjoy pizza and drinks on the second day. All proceeds will be donated to the Buckeye Valley Basketball programs, the Scott Thomas Basketball Scholarship and to the outreach programs within the Buckeye Valley community. Since 2015, over \$14,500 has been donated to the Buckeye Valley basketball programs and to the Scott Thomas Basketball Scholarship. Two \$500 college scholarships were awarded to Baron basketball players in 2016, 2017, 2018, 2019, 2020, 2023 and two \$500 college scholarships will be awarded spring 2024. ST10 Basketball and proceeds from ST10 golf outings have donated \$20,000 to Buckeye Valley East after school programs.
