PRINCIPAL'S MESSAGE

Athletics

The athletic program is an important part of the school; however, it is secondary to the academic program of the school. There are certain requirements that students must meet to participate in athletics:

1. Student must be in 7th or 8th grade.
2. Student must have passed a minimum of 4 classes (at least 3 of those must be core courses [Math, Science, Social Studies, Language Arts] plus 1 Encore class) from the previous semester.
3. Students will forfeit athletic eligibility when unlawful/unexcused absences, out-of-school suspensions, or any combination of unlawful/unexcused and out-of-school suspensions during the previous semester exceed ten (10) days.
4. Student must not have turned 15 on or before August 31st of the current school year. There are only two years of eligibility in middle school.
5. Student must receive a medical examination each academic year from a duly licensed physician, nurse practitioner or physician assistant.
6. Student and his/her parent must sign an Athletic Participation Permission form that

includes the Gfeller-Waller Concussion Awareness form **prior to** participating in any tryout, practice or contest (new form must be signed each academic year).

There are also general athletic guidelines for Dixon Middle School:

- ❖ All fees and fines must be paid for a child to be eligible for athletics!
- ❖ Parents are responsible for the transportation of their child to and from practices and home athletic events. A student must have timely transportation to participate.
- ❖ All practices and tryouts are closed to visitors.
- ❖ Coaches will share rules for individual sports.
- ❖ Team members may not participate in games or practices on days they are absent, in ISS, or suspended from school.
- ❖ **Removal from the team for disciplinary offenses is at the discretion of the coach and/or Administration.**

Attendance

Regular attendance is directly connected to student achievement. It is essential that students be in school every day. According to Onslow County Board Policy #4400, in order for a student to receive credit for a course (**Period Attendance**), a middle school student must be in attendance for 160 days per year-long course which means only 20 absences; 80 days per semester course which means only 10 absences. All absences, whether excused or unexcused will be counted. Students with more than 20 absences (10 within the first ninety days and 10 within the last ninety days) in a school year shall not be promoted to the next grade except by determination of the principal or designee upon careful review of the student's records.

A student is considered absent for the day (**Daily Attendance**) if they are present for less than half the school day (11:10 pm). Absences require notes of explanation. Parents of students who are habitually absent may be charged legally for violation of the compulsory attendance law. Any absence after 10 will require a doctor's excuse.

The following reasons, as stated in North Carolina General Statute, are considered acceptable for being coded excused absences for **Daily Attendance** purposes.

Daily Attendance Excused Codes:

- ❖ Personal illness or injury

- ❖ Death in the immediate family
- ❖ Quarantine
- ❖ Educational Opportunity (Approval from the principal prior to the absence is required and all work must be made up.)
- ❖ Medical or dental appointments
- ❖ Court or administrative proceedings
- ❖ Religious observances

Any student who is absent will have a reasonable amount of time to make up any missed work upon their return to school. It is the responsibility of the student to request the missed work. Extended absences due to serious illness will be addressed by student's teachers and/or the administration on a case-by-case basis.

Bus Regulations

Because the safety of our children is a top priority, it is imperative that all parents and students review the Onslow County Schools' Student Discipline Policies and School Bus Safety Regulations Handbook. Of particular importance are School Bus Safety Student Conduct Rules and Misconduct on a School Vehicle. These policies will be enforced with parents and students receiving written notification of consequences based on severity of violations and prior rule infractions. Please help us ensure that the bus ride for all students is a safe one.

Dixon Middle School General Bus Rules include:

- ❖ Obey the bus driver promptly concerning conduct on the bus.
- ❖ Observe classroom conduct, except for ordinary conversation with students in the same seat, while getting on or off and while riding on the school bus.
- ❖ Be at the place designated both morning and afternoon ready to board the bus prior to the time shown on the posted schedule. The driver is responsible for maintaining this schedule and will not wait for tardy students.
- ❖ Help keep the bus clean, sanitary and orderly and do not damage or abuse the cushions or other bus equipment. Students will be required to pay for damages. For the child's safety, eating is not permitted on the school bus.
- ❖ Do not use drugs, alcohol, tobacco or profane language on the bus.
- ❖ Students are not permitted to use recording devices or radios on the bus.

Consequences for infractions of bus rules may include (but are not limited to): a written warning, suspension from riding the bus for one to two weeks, and up to losing the privilege to ride for the remainder of the school year. The consequences assigned are at the discretion of the administration and the transportation office.

Child Nutrition

Child Nutrition offers healthy meals every school day. Each student is assigned a computerized student number to purchase breakfast and lunch. This number is to be used by that student only. Students may use their lunch number only once per meal. Misuse of another student's lunch number is considered theft and will result in disciplinary action. Breakfast costs \$1.25; lunch costs \$2.50. Students may qualify for free meals or for reduced price meals.

A new application is required EACH school year beginning July 1 and are available throughout the school year.

Families who feel they may qualify are encouraged to fill out and submit meal benefit applications.

One application per family can be completed. *The information provided will be used to determine eligibility for free or reduced-priced meals. This information may also be used for other state or federally funded school benefits.*

If your family chooses to apply, please complete a **"Free and Reduced Meal Price Application Form."** Applications can be completed online at www.lunchapplication.com.

Communicable Diseases

If a child has a communicable disease (for example, pink eye or head lice) Board Policy 4230.5 requires that he/she remain at home until the disease is no longer contagious for the protection of other students and staff.

Conferences

We encourage parent-teacher conferences. A parent-teacher conference or a phone call to a teacher is the first step a parent should take if there is a concern. Conferences should be scheduled with the child's teachers or by calling the school at 347-2738. FERPA (confidentiality regulations) requires that conferences be arranged by the legal parent or legal guardian and

that the legal parent or legal guardian be present at the conference.

Extra-curricular Activities

Attendance at school socials and other after-school activities is considered a privilege. Students who owe fees are not to attend these events until all charges have been paid.

Acceptable dress per the school dress code and good behavior are required in order to attend. Students will not be permitted to attend socials if they are assigned ISS or OSS on the date of the dance or if they have repeated behavior problems at school as this might be considered a safety issue. Students must be picked up promptly after the event. Students picked up more than 30 minutes after an event may not be allowed to attend future events.

Grade Reports

To keep parents informed and involved in their child's education, Report Cards will be sent home every nine weeks. Interim reports will be sent home at week three and week six of the grading period. Parents are also encouraged to sign up for Parent Portal on PowerSchool so that they have up to date information on their child's grades.

Hall Passes

When it is necessary for a student to be out of class for any reason, he/she must have a pass. Hall passes for specific destinations are used by each teacher. Failure to have a hall pass from a teacher will be considered skipping class. Only one student from each class should utilize a hall pass. Students should proceed directly to their destination without unnecessary detours.

Inclement Weather

In the event of inclement weather, OCS sends out phone alerts and posts to the websites to notify students, parents and staff of school delays and closings. Parents/Guardians should ensure contact information is up to date. In the case of delayed opening, the buses will also run late.

Instructional Time

One important way that a school can have a positive and direct impact on student achievement is through the protection of instructional time. For this reason, **no visitors will be allowed in classrooms during the school day** unless they are a guest speaker, part of a planned instructional activity, or have planned ahead of time with the front office.

Media Center

Students may check out a maximum of two books at a time. Books may be checked out for a two-week period and may be renewed twice. Students with overdue or lost books cannot check out additional books until this is taken care of. If a student loses or damages books that are checked out in his/her name, the student is expected to pay for the book.

Medication

Except in special circumstances, which have been approved by a physician and the school nurse (i.e., certain asthma inhalers), all medication is dispensed from the school office. All medications require a physician completed medication form completed that is filed with the school. **This properly completed form and the medication need to be brought to the office by the parent/guardian.** Students are not permitted to carry medicine themselves nor are they allowed to self-medicate. For safety reasons, over-the-counter medications (i.e., Tylenol, cough drops, eye drops, etc.) cannot be dispensed by school personnel or used by students without a physician's written order. Students cannot carry over-the-counter medications on their person or in their personal possessions. **Students who bring medication to school and do not comply with these guidelines will be disciplined, to include possible suspension from school and referral to legal authorities.**

Moment of Silence

The Onslow County Board of Education Policy #3330/4050, authorizes the observance of a moment of silence each day in all grades in the school system. A moment of silence may not exceed one minute in length, must be completely unstructured and free of any influence from any source, and no other activity will be allowed during that time. DMS observes a moment of silence at the start of the school day.

Parent Support Organization

Dixon Middle School encourages parents to form a school support organization. If you are interested in establishing building, or joining, please call the school so that we can get you a contact form for this organization.

Promotion/Retention Standards

OCS Board of Education Policy #3420:

"..In order to be considered for promotion, students in grades 3 through 8 shall perform at least at grade level as identified by the state end-of-grade tests, observations, grades, teacher-generated, locally-generated, and state-generated assessments; work samples, portfolios and/or other factors in all areas of the curriculum.

It is recognized that the final authority to grade and place students is the responsibility of the principal, in accordance with G.S. 115C-288(a). The principal shall consider the pupil's classroom work and grades, the student's scores on standardized tests, and the best educational interests of the student."

6-8 Additional Promotion Requirements

Students in grades six through eight must earn a passing grade in a minimum of 5 yearlong or equivalent yearlong combination curricular classes, two of which should be language arts and mathematics.

6-8 High School Credit-bearing Courses

A student in grades 6-8 who chooses to enroll in a high school credit-bearing course will be held to the High School Diploma Standards as indicated below.

High School Diploma Standards

To receive a North Carolina high school diploma, all students must meet all existing local and state graduation requirements (as noted in Policy [3460](#) Graduation Requirements).

Reporting Harassment/Threats/Bullying

Harassment, communicating threats, and/or bullying reporting forms for students and parents are available in the front office and on the school's webpage. Students, parents, volunteers and/or visitors are encouraged to submit any complaints of discrimination or harassment, other than sexual harassment, through the grievance procedure established in Policy #1740/4010, Student and Parent Grievance Policy. Reports may be made anonymously, and all reports will be investigated. Once the investigation is completed, violations may result in in-school or out-of-school suspension.

School Counselors

Students may request to see the school counselors via the form located on the school webpage. Students are encouraged to work with the counselors for **personal** guidance and for information on grades, study help, and testing programs. Counselors are available to discuss any home, school, or social concerns. The counselors are also available for assistance with peer mediation.

School Hours

The classroom doors will open at 7:10 am. Students will not be permitted on campus before 7:10 am unless they are attending scheduled tutoring or a school sponsored activity. They will not be allowed before this time because there is no one to provide supervision. Breakfast will be available at 7:10 am. Students eating breakfast must remain in the cafeteria. Any student not eating breakfast will report

straight to their homeroom class upon arrival on campus. The first bell will ring at 7:25 am and the tardy bell will ring at 7:30 am. Students who arrive in their classroom after 7:30 am will be marked tardy. School officials will notify parents when tardiness becomes a recurring problem. Students are expected to leave school immediately following dismissal at 2:40 pm, unless they are involved in a school-sponsored activity.

Signing In/Out

Late arrival/early checkout is strongly discouraged. Students miss valuable instruction and will be counted absent or tardy in accordance with the county attendance policy. Students will not be released to anyone but a parent, legal guardian, or emergency contact with proper identification.

To prepare for dismissal and to ensure the safety of all students, it will not be possible for students to be checked out after 2:20 PM.

Student Recognition

We believe in recognizing and rewarding excellence in our students. We have several recognition programs:

- ◆ Honors Assemblies—Celebrations will be held at the end of the year to recognize students who have been on honor roll and principal's list all year.
- ◆ Students receiving Honors recognition each nine weeks will be awarded a certificate from their homeroom teacher.
- ◆ Grade-level incentive trips/socials—Details about eligibility will be shared by each grade level team.

Student Physical Examination Requirements

Physical examinations for middle school students will be required only for those participating in athletics, or those students who are unable to participate fully in regular PE classes. The doctor should indicate limitations in PE classes on the physical form or in a written note. Any student who is under a doctor's care cannot participate in athletics or PE until the doctor provides a written release. *Physical forms must be presented to the coach prior to the first day of practice or try-outs for any athletic team, including cheerleading.*

Telephone

Students will not have access to the telephone, except in emergencies such as illness. For this reason, students need to make sure they are responsible and bring homework, projects, uniforms, instruments, etc. with them to school. No student will be called out of class to the phone unless it is an emergency;

instructional time is of the utmost importance. The phone is for official business and not personal calls. Arrangements for pick-up, staying after school, etc. should be made before the student leaves home each morning.

Textbooks/Laptops

Students are expected to take proper care of all books/laptops issued to them or used in the classroom or library. Students are responsible for returning all books on schedule. **If a book/laptop is lost or damaged, it must be paid for.** Students must be responsible for their books/laptops and these should not be left unattended. Students are expected to bring their books/laptops to class daily unless directed otherwise by the teacher. **When student is issued a 1:1 laptop, both the laptop and charger must be returned to the school at the end of the year. A fee will be assessed if any part is missing.**

Traffic Flow - Commuters

Morning Car Rider Line:

- ❖ **Operates from 7:10 am – 7:30 am.**
- ❖ Students **may not** be dropped off from any parking areas or any other location. The parking lots will not be open during the car line hours.
- ❖ **Supervision provided by DMS staff:** Please watch and listen for the supervising staff's directions. **Parents should not get out of their vehicles for any reason nor talk/text on cell phones while in the drop-off line.** Please remain in the line. Do not pull around other cars.

- ❖ **Exiting vehicle:** Students should exit their vehicle from the passenger side.
- ❖ **Exiting drop off area:** Do not move your vehicle until DMS staff has given you the ok to move. When exiting, please look ahead and behind when moving your car. Please be patient. Students are precious cargo and will be provided the safest environment possible.

Afternoon Car Rider Procedures:

- ❖ **Operates from 2:40-3:00 pm.** During afternoon pick up, students will be asked to wait on the sidewalk.
- ❖ Students **may not** be picked up from any parking areas or any other location. The parking lots will not be open during the car line hours.
- ❖ **Supervision provided by DMS staff:** Please move forward in line as directed by staff until the loading zone is full.
- ❖ **Loading vehicle/Exiting car rider line:** Students will be released to load cars once the line has stopped. Once vehicles are loaded, they will not be allowed to leave the line by driving around others. All loaded vehicles will be dismissed in an orderly fashion. Please pull forward when directed to do so by the staff and be attentive of when the line is stopping. **Parents should remain in their vehicle at all times and should not talk/text on cell phones while in the pick-up line.**

These guidelines should make commuting to school safer for students and more efficient for parents.

Visitors

All visitors are to report to the school office when they arrive on the school campus. All visitors must sign in and receive a visitor's pass before being escorted to their meeting or conference. No visitor is to be unescorted on the campus at any time. The safety of our students is a top priority. Thank you in advance to all visitors for your support of this policy.

STUDENT CODE OF CONDUCT AND DISCIPLINARY PROCEDURES

The rules and regulations are established for the health, safety, and welfare of all students. Students are responsible for knowing the rules and policies of the school system and DMS. The following listings are the basic rules. However, additional regulations may be added as necessary. Please refer to the Student Related Board of Education Policies and School Bus Safety Regulations handbook that your child was given by their homeroom teacher for additional important policies. Whenever possible, student discipline will be handled between the teacher, student, and their parents. Dixon Middle School is dedicated to effective school/family communication, and it is through this contact that we can meet the needs of each individual student. Each teacher has a written classroom management plan that they will share with students and parents at the start of the school year.

Aggressive Behavior

Aggressive physical contact between students is a safety risk for the students involved, as well as those around them. Shoving, kicking hitting, pushing, slapping, etc. regardless of intent are unacceptable behaviors. Even when students are "playing around", they run the risk of injury or an escalation into hostile behavior or a fight. An investigation will take place.

1st Offense: up to 3 days of ISS

2nd Offense: up to 5 days of ISS

Affection

Public displays of affection are not acceptable at DMS. A warning will be given, and parents will be called. Continued behavior will result in disciplinary action.

Bomb Threat

House Bill 517 - Making or communicating a false bomb threat is a serious crime and is now considered a felony in North Carolina. Perpetuating a bomb threat hoax by bringing fake explosive devices into schools or school events is also a felony. Encouraging or aiding a minor in bringing explosive devices on a school campus is also a felony crime. Parents who are found to be negligent with regard to their children, or who commit these crimes, may be required to pay restitution.

Bullying/Communicating Threats

Any action, whether physical, verbal, or non-verbal that is meant to intimidate or demean another student or a staff member will not be tolerated. This includes racial slurs. Any reports will be investigated and documented by school officials. Parents of all parties involved will be contacted.

1st Offense: up to 5 days of ISS

2nd Offense: up to 5 days of OSS

3rd Offense: up 10 days OSS

Additional offenses: OCLC referral or long-term suspension

*Repeated offenses may result in referral to law enforcement.

Cell Phones/Cameras/Personal Devices

Cell phones, cameras and personally owned devices are not to be used on campus during the school day except when approved by a school official. Cell phones and ear buds should not be used during transition times. **All cell phones should be turned off or on silent and placed in a secure area of the student's purse or book bag so it cannot be seen.**

OCS Policy 4318: Use of Wireless Communication Devices

Students may not record any portion of an active classroom without the consent of the teacher.

Students may not take pictures or video of any tests or assignments without the consent of the teacher. **Students may not video other students with or without their consent for any purpose other than instructional.**

Onslow County Schools 1:1 Responsible Use Guidelines includes the following:

- *Any video, audio, or photographic recording in classrooms or other areas designated for student learning without prior consent from the teacher and/or school administration is strictly prohibited.*
- *Any video, audio, or photographic recording in restrooms, locker rooms, or any other areas where privacy is an expectation is impermissible. Violations of this rule may result in criminal charges.*

Students can expect to have these items confiscated and turned into the office if they are in violation. 1st offense: item will be returned at the end of class. 2nd offense: item returned at the end of the day. Repeated offenses will require item to be picked up by parent/guardian and possible disciplinary action. **Refusal by a student to give up an item to a school official or staff member will result in ISS/OSS.**

Cheating

Cheating/Plagiarism is not tolerated. This can include turning in someone else's work as your own. Students caught plagiarizing/cheating will make up the

assessment/ assignment in question in an alternate location.

Cologne/Perfume/Spray Deodorant

Colognes, perfumes, and spray deodorants can trigger adverse medical reactions for many students and staff. Colognes, perfumes, and spray deodorants must be left at home. Students in Physical Education or participating in athletics after school, should bring a form of solid or roll-on antiperspirant/deodorant. Sprays are not permitted in locker rooms, even during athletic functions or practices. These items will be confiscated and will need to be picked up by a parent or guardian.

Disruptive Behavior

Classroom rules are established in order to maximize instructional time. Students should always be mindful of how their actions impact the learning environment for all students. Students who are talking excessively, out of their seat, and distracting other students cause a disruption to the learning of the class and is therefore unacceptable. Continued behavior of this type will result in disciplinary action and a behavior plan as needed.

Dress Code

Students are expected to dress appropriately while at school. *Administration will make the final decision on appropriate school dress. Special days such as hat days are approved on occasion at the discretion of administration and will be announced in advance.*

The following attire will be the Dress code for ALL Dixon Middle School students during the instructional day.

Do Not Wear:

- Exposed undergarments.
- See-through or excessively short, tight, or revealing clothes. All bottoms should be fingertip length.
- Bare midriff shirts. Skin should not show when arms are raised above head.
- Shirts or tops that have a strap less than the width of three fingers.
- Shower shoes or bedroom slippers.
- Clothing with lewd, indecent, or vulgar messages or illustrations.
- Clothing that advertises products or services illegal to minors.
- Head coverings, headgear, or bandanas.
- Head coverings are allowed if they are an expression of a sincerely held religious belief.
- Chains, spikes, or other accessories that could be perceived as or used as a weapon.

- Clothing that violates the school system's policies against gang and gang-related activities.

Students dressed inappropriately will have a parent called for a change of clothing. Students dressed inappropriately will not be allowed to return to class until they are appropriately attired. Any lost class time and class work must be made up.

Drugs, Alcohol, and Illegal Substances

Possession, use, and/or distribution of drugs, alcohol, and other illegal substances are strictly forbidden at DMS and are in violation of the law. Charges will be filed by the School Resource Office (SRO). Students will also be referred to the school counselor. Students involved in these activities will receive out of school suspension. Long-term suspension, alternative school, and expulsion may also result.

Fighting

Any student who engages in a fight and who is determined to have either provoked it or who could have reasonably prevented it from happening will be charged with fighting. Often, students indicate that they have simply been defending themselves in a fight. Defending one's self involves getting away from the fight and notifying a teacher without throwing punches or engaging in the altercation. **Fighting is unlawful on public property and may result in charges being filed by the SRO.** During an exchange, if students are asked to disperse and they do not, they will be disciplined for failing to follow an administrative directive.

1st Offense: up to 5 days OSS

2nd Offense: up to 10 days OSS

Additional offenses: OCLC referral or Long-term suspension

Food, Gum, Candy, Drinks

No food, gum, candy, or drinks (***except bottled water***) are allowed on school property including buses, buildings, or the school grounds during the school day except at lunch and when authorized by school faculty. **Energy drinks are not permitted at any time. Water bottles must be clear. No glass bottles allowed.**

Inappropriate Materials

The possession of inappropriate magazines, books, or *Internet* materials is prohibited. This includes possession of or distributing/showing to other students inappropriate or lewd materials and non-instructional games on school grounds. Disciplinary action can include the following:

1st Offense: Loss of internet and technology and /or up to 3 days ISS.

Repeat Offenses/Severe Offenses will result in additional consequences.

Profanity

The use of profanity in school is strictly prohibited. Please respect yourself and those around you. Students caught using or writing profanity on campus will receive the following disciplinary action:

Not directed towards an individual: Up to 3 Days ISS.

Directed towards a staff member: Up to 5 Days OSS.

Profanity on the bus may result in bus suspension.

Prohibited Items

Students **may not** possess the following items on school property or at school events:

1. Skateboards or wheelies.
2. Pillows and blankets.
3. Non-educational toys.

Refusal of Teacher/Administrator Directive

The refusal to follow reasonable directives of teachers or other school personnel will be considered defiance. Students may not refuse to follow a directive because they do not like the directive or believe it to be unfair. If a student has a question or concern with the directive of a teacher, it should be discussed with the teacher in private or brought to the attention of an administrator at a later time. **Students may not walk out of class without permission.**

*Refusal to follow a directive may result in up to 3 days OSS.

Skipping School or Class

Any student who is not in his/her scheduled class is considered skipping. Failure to sign in or out during the day for any reason is considered skipping school. Any student in the hall without an approved pass is considered skipping.

1st Offense: Up to 1 Day ISS

2nd Offense: Up to 3 Days ISS

Stealing, Vandalism, or Destruction of School Property

Any student found guilty of stealing, vandalism, and/or destruction of school property will be disciplined by the school, pay restitution, and may be referred to law enforcement officials.

Minimum action: up to 3 days ISS

Maximum action: up to 5 days OSS

Tardiness

The school day begins at 7:30 a.m. Any student who arrives after 7:30 a.m. and is not in their assigned homeroom is considered tardy and must be signed in

at the office by a parent or guardian. Please take measures to ensure that students are on time daily.

Technology

All students must have signed permission by parents/guardians to have and use technology or Internet at DMS. Students must follow all school and OCS guidelines and policies for Internet and technology use and will face disciplinary action for failure to do so. These consequences may include, but are not limited to ISS, OSS, and loss of technology and Internet privileges.

Theft

Stealing can be a serious problem in schools. Students should take care to protect their possessions. Items that are valuable or not necessary should not be brought to school. The possession of property (books, clothing, and equipment) that is not your personal property will be viewed as stealing. Such property should be turned into a school official immediately. Students are not permitted to barter, trade, or sell personal or commercial items at school, other than through an approved school fundraiser. The school is not responsible for lost, stolen or damaged property. In these situations, the student will be given the opportunity to file a report with the school's SRO.

Threats of Mass Destruction

Policy Code #4333 Weapons, Bomb Threats, Terrorist Threats, and Clear Threats to Safety

The board will not tolerate the presence of weapons or destructive devices, bomb or terrorist threats, or actions that constitute a clear threat to the safety of students or employees. Any student who violates this policy will be removed from the classroom or school environment for as long as is necessary to provide a safe and orderly environment for learning.

Throwing Objects

Any "wasps", spitballs, rubber bands, pencils, erasers, or any other airborne item or device is a serious **safety hazard** and behavioral issue. This will result in disciplinary action.

Vapes/Tobacco Products/E-Cigarette/Juul

OCS Board Policy #4320:

*The board is committed to creating safe, orderly, clean, and inviting schools for all students and staff. To this end, the board supports state laws that prohibit the **sale or distribution** of tobacco products to minors and that prohibit the use of tobacco products by minors. The board also supports state and federal laws that prohibit the use of tobacco products in school buildings, on school campuses, and in or on any other school property owned or operated by the school board. **For the purposes of this policy, the term***

"tobacco product" means any product that contains or that is made or derived from tobacco and is intended for human consumption, including all lighted and smokeless tobacco products, as well as electronic cigarettes, vaporizers, and other electronic smoking devices even if they do not contain tobacco or nicotine.

Prohibited Behavior - In support of the board's commitments and state and federal law, students are prohibited from using or possessing any tobacco product (1) in any school building, on any school campus, and in or on any other school property owned or operated by the school board, including school vehicles; (2) at any school-related activity, including athletic events; or (3) at any time when the student is subject to the supervision of school personnel, including during school trips.

2 nd offense	Up to 5 days OSS
3 rd and further offenses	Up to 10 days OSS
Additional offenses: OCLC referral or long-term suspension	

All Onslow County Schools are tobacco free at all times and at all activities, including athletic events. This includes students and adults.

Weapons

Any weapon, facsimile of a weapon or item that can be used as a weapon, is strictly prohibited. This will result in up to 10 days suspension and possibly more serious consequences such as long-term suspension. Weapons are reported to law enforcement and charges will be filed. This is a very serious rule violation. **Please read closely the section on weapons in the school system handbook.**
