

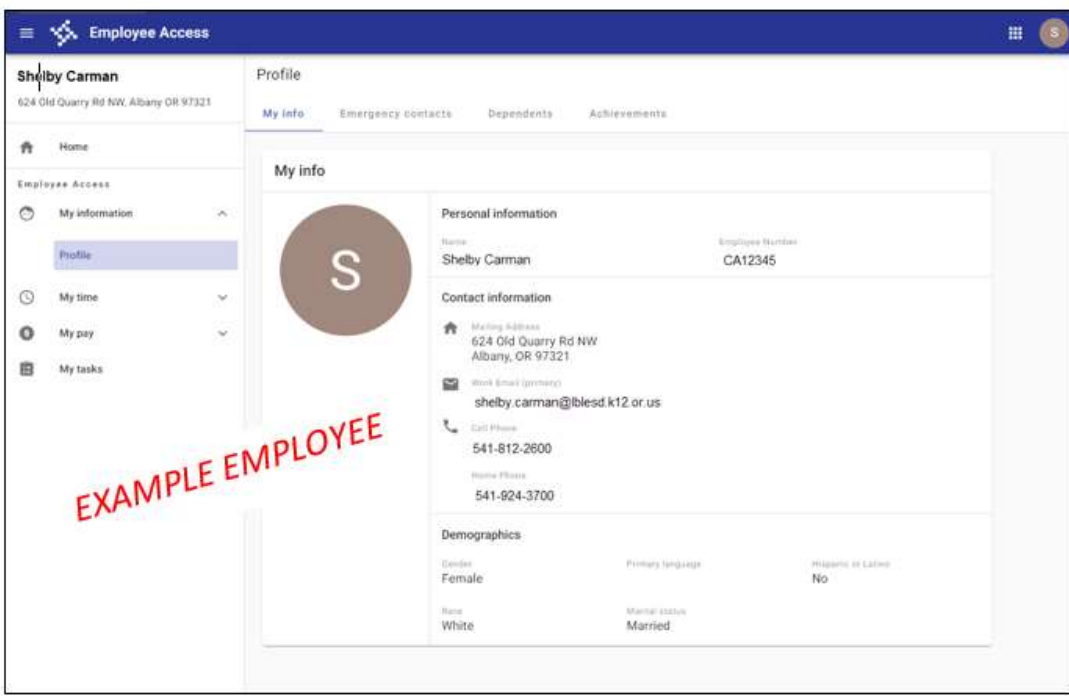

1. Select paycheck from dropdown

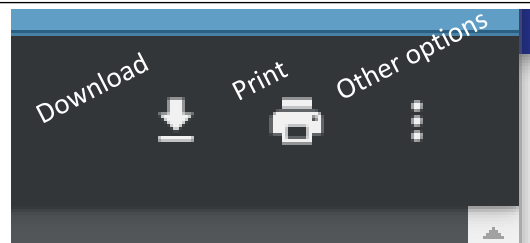
2. Click View Paycheck
